

MESSAGE FROM THE PRESIDENT



The first year following the centenary celebrations witnessed a return to normality for us. In very general terms, we can say that the transition from the first to the second century of the FCI proceeded without any major problems. As 2011 had been an exceptional year for the FCI, various figures for the year under review cannot be compared with the previous year without certain references. As in the three preceding years, we would like to use this business report to give you an outline of our activities and the financial situation of the FCI.

In the wider sense, the 2012 World Dog Show in Salzburg can still be included among the jubilee events of the FCI centenary celebrations on account of the Austrian Kennel Club, one of the founding countries of the FCI, having expressed their wish not to organise a centenary event in the anniversary year 2011.

Austria, as a popular country for spending holidays, and the City of Salzburg, as a treasured travel destination, ensured that a high number of entries could also

be expected on this occasion. Although the World Dog Shows normally take place over four days, the Austrians ventured to hold the event over just 3 days. This meant a considerable increase in the daily number of competitors, which resulted in various difficulties. Experts had reckoned with more than 20,000 dogs taking part in the WDS 2012, so there was some surprise and disappointment when, with a figure of 18,608 dogs, this magic number was not reached. Looking at the causes, it is evident that the shortfall was mainly among those breeds that are still predominantly docked/ cropped in Eastern Europe, but were not admitted in Salzburg. The Austrian Kennel Club succeeded in organising and running this big event with flying colours and without any major hitches. The club and all the officials involved deserve our thanks and recognition for this performance. In appreciation of this and on behalf of the entire team, Dr Michael Kreiner, President of the Austrian Kennel Club, and Ms Margrit Brenner, the WDS Director, were awarded a badge of honour by the FCI. The active participants and the visitors will cherish the memory of a magnificent event and three fantastic days spent in Salzburg.

After the centenary year, we are all back to everyday life once again, where we see that the health of pedigree dogs is very often criticised in the media, sometimes rightly so, but sometimes not. This is an issue where we have to assert our influence. The topics of health, character and behaviour are very important to us. However, we also have to give adequate consideration to dogs being kept in a responsible and appropriate manner. There are already a large number of scientific studies available that deal with trying to solve such questions. I am of the view, however, that this starts with the breeders and it is they who have to pay the necessary attention to the problems of health and character, though the relevant officials in the clubs for the specific breeds and the show judges also have an important part to play in this regard. They all bear a great deal of responsibility in the domain of dog breeding.

The keeping of dogs is being made very difficult in various countries through statutes and regulations. This causes us concern. Furthermore, assistance is being offered more and more frequently by private "experts" and institutes, though often without having the necessary expertise. This mostly does more harm than good. Such matters should once again be resolved more by the canine associations.



General Committee

The General Committee met twice (5 days of meetings) during the year under review to perform the duties assigned to it. The Executive Committee or individual members of the General Committee attended various meetings to deal with business matters that could not be delayed.

The General Committee comprised the following members at the end of the year: Hans W. Müller (Switzerland, President), Rafael de Santiago (Puerto Rico, Vice-President), Stefan Stefik (Slovakia, Treasurer up to 27.10.2012), Dr Tamas Jakkel (Hungary), Kari Järvinen (Finland), Gerard Jipping (Netherlands, Treasurer from 27.10.2012), Jürgen Hindse (Europe Section), Miguel Ángel Martínez (the Americas and the Caribbean Section), Takemi Nagamura (Asia and the Pacific Section).

Cooperation with members and partners

There was active cooperation and exchange of information between the FCI and the members and partners and a great deal of goodwill was shown in tackling and solving problems together. Improvements are still needed, however, particularly with regard to the exchange of information at international level. The General Committee is currently evaluating a project to facilitate such improvements. The members will be informed about this at the 2013 General Assembly.

Cooperation with the Kennel Club, the American Kennel Club and the Canadian Kennel Club

The extent of cooperation with the Kennel Club, the American Kennel Club and the Canadian Kennel Club was normal during the year under review, with consensus being reached on a number of problems in relation to show judging. In the area of canine sports, teams from England, the USA and Canada can compete in our World Championships or section championships, mainly in the agility and IPO disciplines.

Sections

Our sections perform excellent work in their regions. Cooperation with our office in Thuin continues to develop and is beneficial for international cynology. We would like to thank Mr Jürgen Hindse, Mr Miguel Ángel Martínez, Mr Takemi Nagamura and their teams for their great commitment.

General remarks

The global economy improved again somewhat in 2012, which also had a favourable effect on international cynology. However, there are still a number of issues that have to be worked on. I have already mentioned some of these, but there are others that are equally important and meaningful. We have been making efforts for years, for example, to combat dog trading, especially in Europe, though only with moderate success unfortunately. We are dependent on the support and assistance of the national organisations in this fight and it is only by working together that we may be able to bring these endeavours to a successful conclusion in a few years. We feel it is of great concern that important officials of national organisations are evidently also occasionally involved in this matter.

The subject of the training and appointment of judges continues to be a perennial issue. The requirements demanded from the show judges in the different national organisations are excessively disparate. There is still too little account taken of health and a sound nature at shows. For progress to be made, some competitors really do need to change the way they think in the ring.

I would like to sincerely thank my colleagues on the General Committee and in the sections, the members of the commissions, those responsible in the national organisations, as well as Mr De Clercq and his staff at the FCI Office for all the good work they have performed in all the different areas for us and for the dogs.

2012 Annual report

INTRODUCTION

In accordance with the celebration of the 100 Anniversary of the Federation Cynologique Internationale, the General Committee of the FCI reviewed its Mission and Vision Statements and Values to maintain our leadership worldwide.

MISSION STATEMENT

The FEDERATION CYNOLOGIQUE INTERNATIONALE (FCI) is the supreme authority of the canine culture worldwide. The FCI is responsible for safeguarding canine health and international dog activities to enhance the relations between dogs and humans. Established in 1911 the FCI includes 84 members and contract partners (one member per country). Each member issues their own pedigrees and train highly qualified judges. The FCI makes sure that the pedigrees and judges are mutually recognized by all the FCI members, contract partners and any person involved in their domestic canine scene.

VISION STATEMENT

The FCI supports, via its members and contract partners, the well-being of all dogs Worldwide.



Communication means, nowadays, have taken an immense place and play a very important role in our life; this is even more so for an organisation with a definitely worldwide orientation. Facebook and online communication are tools which have become essential and the FCI understood it very clearly.

One of the objectives for the next year will be to make our "traditional" website more attractive extending it with even more information for our members. A major step forward will be the possibility for exhibitors and FCI members to consult the results of CACIB shows online, making it unnecessary to keep the CACIB cards in use. As most FCI members have experienced it, shows applications are now to be done online via a platform specifically designed for that. The next phases, implemented in the course of 2013, will be the possibility to consult your own kennel club's accountancy online and the CACIB results (see above).

FCI NEWSLETTER

The new format of our e-newsletter is now very well accepted and we are happy that we could meet the wish of the FCI members, expressed in 2009 at the General Assembly. It took some time to find out the ideal design, adequate and interesting information but we

now believe that the objective has been reached. This of course does not prevent us from remaining "awake" and attentive to the reactions and expectations of our members and readers in general.

FCI BUILDING

The local and provincial authorities having finally given their approval, the building permit was granted to the FCI and the works will start in the course of 2013. This is a very important decision which shows the willingness of the FCI to settle in Thuin, securing the staff stability, which is of utmost importance in such a diversified and internationally orientated activity. Some parts of the current building will be renovated and/or transformed and an extension will be built with a library, a museum, a meeting room and a huge room for our archives.

OUR STAFF

MAJOR DECISIONS OF THE FCI GENERAL COMMITTEE

Let's take a brief overview of the major decisions made by the FCI General Committee this year.

Proposals from the commissions

Hunting dogs area

For the title of CIT, the 2 required CACIT can be obtained in one country (more countries however acceptable), under two different judges. This applies to all the hunting dogs commissions (Retrievers, Earth Dogs, Spaniels, Continental and British Pointers, Hounds).

Rescue Dogs area

The *"Judging Guidelines"* were approved and entered into force on May 1^{st} , 2012.

Sighthounds Races area

The **new regulations (Races and Coursing)** were approved and entered into force on July 1st, 2012.

Show area

If a dog behaves aggressively in the ring (breed-groupfinals) and its behaviour is eye-witnessed by the judge in duty, the latter has to write a report for the attention of the organising committee and has to disqualify the dog for the rest of the competition. All the awards and titles of the day are cancelled.

The new **Show Regulations** were approved and will be enforced from January 1st, 2013.

Agility area

The new "Specifications for the organisation of the FCI Agility World Championships" and the new "Guidelines for FCI Agility Judges" were approved.



Breeding area

The FCI General Committee approved the following proposal "Breeders must apply for registration of all purebred litters".

Breed standards area

New or amended standards were approved:

Great Dane, English Cocker Spaniel, Airedale Terrier, Collie Rough, Deerhound, Australian Cattle Dog, Kelpie, Australian Silky Terrier, Australian Terrier, Jack Russell Terrier.

It is reminded that the on the website of the FCI, a page, regularly updated, is available listing all the breed standards amended in the last 6 months.

Another task that proved to be very time-consuming was the publication of the updated "FCI Championship **Regulations**" in December.

CHANGE IN THE FCI SCIENTIFIC COMMISSION

We have also wanted to pay a special tribute to a very respectful and respected person, who sat in the FCI Scientific Commission for 27 years and unfortunately decided to resign: Prof. B. Denis (FR). He always served the commission professionally and efficiently. His substitute was appointed by the FCI General Committee: Prof. Leroy (FR) to whom we wish good luck.


PARTNERSHIP APPLICATIONS: BOSNIA HERZEGOVINA

Since December 1st, 2012, the Kinoloski Savez u Bosni I Hercegovini (KSuBiH) (Bosnian Kennel Club) is back in the FCI and this is a very good piece of news for the active Bosnian breeders in that region.



FCI ACTIVITIES

The activities of our members remained stable and high, compared to 2011. **To the date of production of this annual report**, with a total number of international shows reaching 900 for a total entry of 921,805 dogs, our Federation definitely keeps its leadership position. Our office confirmed 97,971 (as of March 27th, 2013) CACIB and 7,960 titles of International Champion (CIB, CIE, CEC, CIT, CIAG, CIOB, CIC). 2,003 trials (hunting, utility, agility, obedience, herding, races) have been sanctioned and 19,297 kennel names were FCI registered.



(Note : the CACIB figures for 2012 do not appear as they cannot be considered reliable. These figures change constantly as our staff is processing the remaining CACIB results for the 2012 shows).

FCI SCIENTIFIC COMMISSION - Activity report

Official Meeting

During the period under review, the FCI Scientific Commission met on February 4-5 in Stockholm, Sweden.

On the first meeting day, the Scientific Commission discussed health and genetics issues raised either by the FCI General Committee (GC) or by the FCI member organisations. In addition, the commission initiated its own ideas and recommendations regarding topics relevant to health improvement of pure bred dogs.

The second day was dedicated to mutual discussions with the Standards Commission on items relevant to new standards, change in standards or health impairment due to standards.

Recognition of New Breeds

The task of the Scientific Commission, in the process of the recognition of new breeds, is to investigate whether there are any severe anatomic or genetic impairments and to take care that the breeding basis of the new breeds is wide and diverse enough (8 blood lines) to enable a healthy breeding.

Furthermore, to investigate whether the potential new breed is a new breed or rather a variety of an already-recognised breed.

The New Breeds which the commission investigated during this period were the Prague Ratter (Prazsky Krysarik), the Bohemian Shepherd Dog (Chodsky Pes) and the Continental Bulldog.

Prague Ratter (Prazsky Krysarik)

The 8 blood lines were provided in the right form. However, no health certification was provided. Therefore, the recommendation for recognition was discussed no further.

The Czech canine organisation has been informed.

Bohemian Shephred Dog (Chodsky Pes)

The list of the 8 blood lines which was provided was not in the requested form. No health certification was provided. Therefore, the breed has not been discussed. The Czech canine organisation has been informed.

Continental Bulldog

Although the health certificate and the 8 blood lines were provided and met the required standards, all 6 commission members agreed that, from genetic and scientific point of view, it is rather a variety and not a breed. . Nevertheless, one member was in favour of the recognition as a breed, while the other 5 members opposed this notion. This issue was further discussed on the next day in the joint meeting of the Scientific and Standards commissions. It was decided not to recommend the FCI General Committee to recognise the Continental Bulldog as a new breed, but rather as a variety.

Elbow Dysplasia

A draft of a written proposal describing the procedure of Elbow dysplasia screening in dogs is currently at work. The object is to acknowledge it as the FCI official procedure, like the one of Hip dysplasia.

Two commission members, namely Dra M. Durán and Prof. A. Hedhammar, actively participated in an international workshop designated to this topic.

Dra Durán presented a guideline of the screening procedure and evaluation of the Elbow dysplasia. It was accepted by the commission, and was delivered to the FCI website for publication.

FCI Working group 2012

The FCI GC has initiated an ad hoc committee that should deal with new approaches to the issue of canine Health, well being and welfare. The president of the scientific commission participated actively in this ad hoc committee.

Its protocol and recommendations were provided to the FCI GC.

The Scientific Commission discussed these issues at its meeting, deciding to participate actively in this project by initiating new steps according to the GC decisions. At a time, the Scientific Commission made a proposal to create expert panels, which would provide knowledge and assistance supporting the FCI central bodies and its member canine organisations.

The first panels, suggested by the Scientific Commission are:

- Orthopedic screening programmes
- · Hereditary eye disorders
- Hereditary heart Diseases

Abbreviations and list of Hereditary Diseases:

Dr Andres Villalobos prepared a comprehensive list of hereditary diseases and disorders in the dog, including their internationally recognised abbreviations, further to a previous request from the Commission.

This excellent list - after being accepted by the Commission - was sent to the FCI for further distribution among the kennel clubs.

Stockholm 2-3 June 2012 – The first international symposium on well being of pure bred dogs

This workshop, first of its kind, gathered representatives from 26 countries (4 continents), which included kennel



clubs representatives, veterinarians, breeders, welfare activists and judges.

The symposium was chaired by Prof. Ake Hedammar, a member of the FCI Scientific Commission.

All members of the Scientific Commission participated actively in the various workshops that were running in parallel.

This workshop was initiated by the Swedish Kennel Club and was supported by the FCI.

Change in the Scientific Commission

Prof.Bernard Denis (France) resigned from the commission in October 2012, after 27 years of fruitful activity. He was replaced by Dr Grégoire Leroy (France). I would like to express my gratitude to all the members

of the Scientific Commission, who contributed so much to the tasks of the commission, always willingly, effectively and in a friendly atmosphere.

FCI STANDARDS COMMISSION - Activity report

The Commissions former president, Mr Raymond Triquet is much appreciated as the Commission's senior adviser, a position he has held since 2007 when he resigned from the full membership.

The Standards Commission's main work to revise and adapt new and existing standards is constant. Focus on dog's health has caused countries to review the text in standards extra carefully to avoid wordings that may result in interpretations that can lead to exaggerations that might cause health risks. This has increased the Commission's work in the last couple of years.

The Commission still has one annual meeting only and hence the procedure for standards to be revised can take a year, or more.


The Commission continuously amend or thoroughly revise standards and the co-operation with the member countries is usually efficient. Still, the procedure has to go through several steps before a standard can be published, and rightly so as these documents are the back bone in the work of the FCI and its member countries.

Viewing of the text in standards from a health and welfare perspective is intensified. This is not always to the liking of the countries of origin but in the interest of keeping the breeds for the future. We all have accepted that exaggerations in type as well as character issues in guard dogs might not only jeopardise the health of the dogs, it may also increase the risk to have breeds banned by law. This has already happened in some countries.

Illustrations in standards

The Commission is pleased to notice the interest member countries are taking in producing good illustrations for the front cover of the standards. The illustration with anatomical features to be used on the back cover of the standards is now completed with text in the four FCI languages.





The illustration of Anatomical features was prepared by the Standards Commission and is to be used on the back cover of all FCI standards. This was approved by the GC in 2012. The illustration is by the late Australian artist Margaret Davidson featuring an Australian Cattle dog. The use of this drawing was permitted by the Nordic Kennel Union whose Picture Library owns the rights to the original.

Commission meeting in Stockholm

The Commission's 2012 meeting took place in Stockholm in June in connection with the 1st International Workshop on Enhancement on Genetic Health in Purebred Dogs. The Workshop was held as a post-conference to the 6th International Conference on Advances in Canine and Feline Genomics and Inherited Diseases.

Renée Sporre-Willes made the introduction to the workshop for Prerequisites and procedures for recognition of breeds and varieties. The main discussion points being:

- · How to avoid breeds being divided up by e.g. size, colour and coat?
- Breeds versus varieties of the same breed.
- Is it beneficial to make new breeds out of those already existing?

Some of the conclusions by the whole conference were:

That a 100% of the participants said NO to make new breeds from those already existing.

The name of the breeds, in number order can be found below

- The opinion was that it is better to save an already existing breed with infusion of new genetic material instead of creating a new breed from a small founding population.
- Alternatives mentioned were a national recognition with an open register. For international recognition there should be extended rules such as 20 years minimum as a national registered breed; known health status based on official health screening etc.
- Improvement of health and diversity may be obtained by crossing varieties and potentially by combining breeds that are genetically related.

A few pictures of breeds that "look alike" were added to the introduction by Renée Sporre-Willes. "Guess the breeds" caused some amusement as well as serious thoughts.

The pictured breeds are not the only ones that give food for thoughts as to how genuine our breeds really are. Many are merely a variation of the same theme.

FCI AGILITY COMMISSION – Activity report

The Agility sport seems to be the most important part of the dog sport worldwide since it is increasing year after year. For that reason every year we do have three big international events, and FCI members (the canine organisations) can apply via the FCI Agility commission to be the host for these events.

In the middle of July we had the Junior European Open in Pinkafeld (Austria). This event is only for the youth and "OPEN" which means that not onlyo teams from Europe, but also teams from all over the world are allowed to be part of it as long as they run in according to the valid rules for this special event and are entered by their kennel club. In 2012, 385 teams joined this event. First time we had teams from USA and Russia, too. Four judges – three from Austria and one from Switzerland - built the courses and judged the runs.

The starters compete in two competitions - Individual and Team - each are held in the categories Large, Medium and Small separated by children and juniors.

Two weeks later, at the end of July, the European Open Agility was held in Kristinastad (Sweden) with more than 400 starters coming from almost 30 nations; besides the European, we could welcome competitors from Venezuela, USA, Japan, Canada and Brazil. Because of the high number of entries five judges were appointed: three from Sweden, one from South Africa and one from Italy. It was a real well organised event, an advertisment for the Agilty sport.

Besides these annual sport events the delegates of the FCI Agility Commission were also invited to two meetings; the first one was held in February in Prague and the second one in October, linked to the World Championships in Liberec. Thirty four nations confirmed their FCI delegate for the

FCI Agility Commission, but usually twenty to twenty-five countries only were represented in our meetings.

At the meeting in February we worked on additions/changes to the rules and regulations for JEO, EO and the Specifications for World Championships. Proposed amendments to the guidelines for judges were discussed and the working group for these guidelines will draw up the new version.

The final confirmation of the judges' guidelines and the request to the FCI General Committee to approve these guidelines was done at the October meeting, too.

It has been proven that the working groups, set up by the FCI commission, for the judges'- guidelines and the guidelines for the agility obstacles are very useful. These working groups summarise additions and ideas for changes. They then give these proposals in a compressed form as draft to the delegates. This enables all the countries belonging to the Agility Commission to obtain the drafts in time to discuss the proposed changes in their own nations, and even before the FCI Agility Commission meeting is held, they are able to give appropriate feedback to the working groups.

Overall, I want to thank those who have been host of one of our international events, my board members, delegates and all the members of the working groups for their cooperation. In these thanks I would like to include the members of the FCI General Committee and the employees of the FCI office equally.

FCI BREEDING COMMISSION - Activity report

The annual meeting of the Breeding Commission was arranged in Stockholm June 15st 2012, with excellent hospitality and accomplishment of the Swedish Kennel Club. The meeting took place just prior to the 1st International Workshop on Enhancement of Genetic Health in Purebred Dogs, which was arranged by the Swedish Kennel Club on June 2-3. Most of the Breeding Commission delegates precipitated in this important and well arranged event, which had the subtitle *Breeding healthier dogs – from attention and awareness to action*.

Representatives from the following member countries were present at meeting: Belgium (Mr Roger van Hoenacker) Denmark (Mrs Birgitte Schjøth), Estonia (Dr Janne Orro), Germany (Dr Peter Friedrich), Italy (Ms Maria Ceccarelli), Latvia (Ms Baiba Rumba), Luxembourg (Mr Nicolas Schwab), The Netherlands (Mr John Wauben), Norway (Dr Astrid Indrebø), Poland (Mr Tomasz Borkowski), Portugal (Mr Luís Gorjão Henriques), Slovenia (Mrs Marija Kavcic), Sweden (Ms Britt-Marie Dornell) and Switzerland (Mrs Yvonne Jaussi), as well as Mr Kari Järvinen from the FCI General Committee.

Many important issues were discussed, among them the situation of the Cavalier King Charles Spaniel. John Wauben (Dutch canine organisation), presented an excellent Powerpoint presentation, and informed about the Dutch programme and the project of Mr Arnold Jacques (from Belgium) with whom they are doing a very interesting relation project. The Netherlands, Belgium, UK and Germany are important parts of this project, which are dealing with the two major problems of Cavalier King Charles Spaniel: syringiomyelia (SM) and heart problem (MVD). the Dutch canine organisation plans to organise an International Cavalier Congress for all breed clubs and FCI members in 2013 in Amsterdam. As a result of the discussion in Breeding Commission 2011, FCI took immediate action. A meeting with representatives from FCI and the Dutch canine organisation was arranged in Amsterdam on 27.06.11. The FCI office sent out a request to all the national canine organisations in August 2011, and asked them to send population information about cavaliers (registration numbers, health programmes, mortality data). Few countries did, however, respond to this request. The Breeding Commission therefore proposed in the 2012 meeting that the request should be sent out once more from the FCI General Secretariat, including a list of the kennel clubs/breed clubs who had responded. The answers should be sent directly to Kirsi Sainio, who also received the previous answers.

The following proposals from the Breeding Commission were sent forward to the General Committee

Approval in breed standards of coat, colours and anatomical features which are genetically impossible to avoid in order to breed dogs that are accepted in the standard

Background

The Breeding Commission has in 2010 and 2011 discussed the standard of the Peruvian Hairless Dog (Perro sin pelo del Perú), where the hairy variation was not excepted in the breed standard. We were informed in 2011 that the KCP (Peruvian canine organisation) had sent a new standard to FCI, which had been sent to the FCI Standard Commission. So far the new standard is not available at www.fci.be, but hopefully will include the hairy variation.

Peruvian hairless dog is, however, not the only breed where the standard excludes healthy dogs which are <u>genetically impossible</u> to avoid in order to breed dogs that are accepted in the standard. What about Rhodesian (or Thai) ridgeback where dogs without a ridge are disqualified, although ridgeless dogs in most cases will be born when breeding ridgeback dogs? The gene for ridge is dominant, and it is known that dogs that are homozygote for this gene have a higher risk for dermoid sinus (*Hillbertz NHC, Andersson G. Autosomal dominant mutation causing dorsal ridge predisposed for dermoid sinus in Rhodesian ridgback dogs. J Small Animal Practice 2006; 184-188).* When breeding harlequin Great Dane, merle will appear in the litter. Nevertheless, merle is a disqualifying coat colour in this breed.

Dr Peter Friedrich (Germany) informed that ridgeback dogs might be banned by the government in Germany if the ridgeless dogs are not equally accepted.

Proposal to the General Committee: It is <u>genetically</u> <u>impossible</u> to breed naked dogs without getting the hairy variation, or harlequin without getting the merle colour – or healthy rigdebacks without ridgeless dogs being born. Therefore coat, colours and anatomical features that genetically must appear in a breed in order to breed what is now preferred in the standard (i.e hairless, ridgebacks), should be equally accepted in the standards; the standards must be changed to achieve this.

Breeders should be obliged to apply for registration of all purebred litters

In the present FCI rules, a breeder can choose not to apply for registration for a litter that does not follow the rules of the national kennel club, i.e. to avoid penalties from the national kennel club.

Proposal to the General Committee: The Breeding Commission proposes that the following sentence is added in article 18 in FCI Breeding Rules: Breeders must apply for registration of every purebred litter.

The use of FCI approved kennel names

In some countries breeders are using their FCI kennel name on litters/breeds that are not registered in the stud book of the FCI-recognised national kennel clubs. Ex: A breeder of Labradors can of course use his kennel name to register Helleforshund (which is a national registered breed in Sweden, but not yet approved by FCI), but cannot use his kennel name on breeds that are not recognised by FCI or any FCI-recognised national kennel club.

Proposal to the General Committee: FCI approved kennel names should only be used on litters <u>registered in the stud</u> <u>book of the national kennel clubs</u>. This point should be stated in the agreement signed by the breeder applying for the FCI Kennel name.

Cancellation of a limited registration

The Breeding Commission's proposal to the General Committee: A limited registration can only be revoked by the national kennel club who has made the original limited registration.

Breed typical movements and confirmation, according to the breed standard

Background

In 2011 the Breeding Commission, proposed to the General Committee that the Breeding Commission, Standards Commission and the Judges Commission should work together on this subject. Judges education is of outmost importance. The Standards Commission could provide videos of typical movements and actions of several breeds where there are differences in breed type.

Proposal from the Breeding Commission 2012: There are no financial possibilities within the FCI for funding such an enormous project. There are, however, already lots of national materials in many kennel clubs concerning their national breeds. The Breeding Commission will suggest that FCI should request Powerpoint presentations and/or videos from the countries of origin to be published on the FCI website.

EUROPEAN CUP FOR BRITISH POINTING DOGS 2012 in Nis (Serbia)

POINT OF VIEW OF A JUDGE by Franco Malnati

It is neither easy nor common being one of the judges assigned to judge a European Cup. For this reason, my notes feel the effect of pride and enthusiasm for having judged the most prestigious International event.

The best dogs among the selected ones from 17 European countries run the European Cup. The attention of the judges is focused on the evaluation of the performance, the style, the qualities, the cleverness and what happens minute by minute during the round of each participant.

Actually, the rules of the European Cup (Grande Quete) for English Pointing Dogs states that the Jury must be severe towards subjects which are not up to the situation and which do not have a sufficient dressage. The purpose of the judgment is to bring to the fore the Elite dogs. The judges must give more importance to the whole performance than to faults of little account.

We are in Serbia, on excellent grounds although very peculiar compared with our customs, a "history" on French, Spanish, Greek and Polish grounds. The grounds in Nis show the better we can have today for our trials for pointing dogs. The non-uniformity of the crops, the large areas which are still worked with non modern systems with plots intercropped with fields of wheat, alfalfa, corn, meadows, fallows, etc.., represent the best habitat for the grey partridge which is present in considerable quantity. Greece, The Netherlands, Russia, Serbia, Spain, Switzerland, Turkey, Ukraine and Italy.

To conclude those days full of satisfaction, the success of the Italian team.

It is on these grounds that the trialer, beyond the dressage, must do the best and shows its intelligence in hunting.

In the case of the European Cup, where the best selected dogs from every nation run, the Judges have no difficulty to detect and distinguish the great trialer from the subject which performs its task and also reports valid marks.

The European Cup is a team competition in which all the members of the same team are linked each other and share the same national pride.

The final score is the result of the points of those classified dogs belonging to the same team, with a minimum of two subjects per team.



FCI EARTH DOGS COMMISSION - Activity report



The Earth Dog Commission's objective of compiling transparent guidelines was achieved, and the Commission now has a total of nine sets of (trial) regulations and guidelines adopted by the FCI General Committee. These are:

- International Working Championship (CIT)
 Special Regulations for Earth Dogs
- Euro Cup Trials (ECP)

for Earth Dogs - regulations

- International Utility Test (InterGP)
 for Fox Terriers
- Internat. Post-Shooting Test (InterPndS)
 for German Hunting Terriers
- International Versatility Test (InterVP) for Teckels
- International Utility Test (InterVGP) for Teckels
- International Rabbit Den Test (InterKanin) for Miniature and Rabbit Teckels
- International Fox Den Test (InterBau) for Earth Dogs
- Grand Prix for Earth Dogs (GPE) for all Earth Dogs

The Commission's new presence on the FCI website allows you to consult all regulations and guidelines online and to gain further information and details of events concerning earth dogs. (http://www.fci.be/ commissions.aspx/FCI COMMISSION FOR EARTH DOGS).

The European Cup Trials for Teckels were conducted in Hungary on 25 - 27 May 2012, with the FCI «InterVGP» trial regulations being used for the first time. 17 teams were entered, 14 of which actually turned up. The 14 teams came from the Czech Republic, Finland, Belgium, Germany, The Netherlands, Austria, Hungary and Switzerland. 5 teams successfully completed the trials. The overall winner of these demanding trials, a team from Switzerland, achieved the coveted CACIT (qualifying it for the FCI International Working Dog Title).

The European Cup Trials for German Hunting Terriers took place in Sweden on 24 - 26 August 2012 under the PndS (post-shooting test) trial regulations. 15 teams from throughout Europe were entered for these demanding trials, 14 of which actually turned up. 11 teams were able to successfully complete the trials, with the CACIT being awarded to a German team.

24 - 26 August 2012 also saw the first «Grand Prix for Earth Dogs" (GPE) taking place in Thuringia (Germany).13 teckel teams and one Border Terrier team from Belgium, Germany, The Netherlands, Switzerland and the Czech Republic did their best to fulfil the high requirements, with five teams successfully completing the trials. A team from the Czech Republic was the overall winner. Unfortunately, no team achieved the score needed for the FCI CACIT.

Pursuant to a resolution of the FCI General Committee, as of 1.1.2013 the CACIT can only be awarded at hunting dog trials officially recognised by the FCI (i.e. trials at which FCI international trial regulations (IPO) are used).

Further work awaits us. The 2013 delegate conference, scheduled to be held in Rome, is set to show us the way forwards.

FCI SHOW COMMISSION - Activity report



The Lithuanian Cynological Society (LKD) invited to host the annual FCI Show- and Judges Commissions meeting on the weekend of February 4th and 5th, 2012 in Vilnius, and we thank the Lithuanian for a well organised weekend. They could not be blamed for the fact that Vilnius met the delegates from both the northern and southern part of Europe and South America with arctic temperatures down towards -30C. The hospitality was excellent and the dinner in the Town Hall with the champion of champion contest was excellent.

Even though it was freezing cold outside and also in some rooms, the discussions during the meetings were enthusiastic and interesting and kept us all warm. The delegates put the final wording into the revised FCI Regulations for Dog Shows, and later in the year after a round of small corrections of wording with the FCI office, the Regulations were approved by the FCI General Committee and made valid from 01.01.2013. It is now important that FCI follows up that all member countries get to know the changes and follow the new regulations. Leif-Herman Wilberg, Nic Schwab and Wenche Eikeseth were reelected a President, Vice President and Secretary.

The worldwide economic crisis is a challenge to the show organisers with dropping entries in many shows. Many countries have tried to counteract this decrease in entries by trying to make their shows more attractive, either by giving CACs in every class or by organising back to back shows. The result of this is many cheap champions and too many shows which also tend to reduce the number of entries.

During the year one of the major discussion themes has been the organisation of national shows in foreign countries, and if this practice is in the best interest of the FCI. The commercialisation of our shows and the continuous search for all sorts of titles makes me afraid that the basis for breeding typical and healthy dogs is lost on the way. When most dogs are champions or winners and the use of the quality grading is reduced to excellent and very good, new breeders will have difficulties recognising the really good dogs, and gradually the quality of our dogs will go down.

The number of countries present at these Commission meetings is gradually increasing showing the importance of our discussions and decisions. Last year the number of countries present was 28, with only three delegates from other sections than Europe. In order to try and bring the countries in South America more active in the commission it was decided to organise the 2013 meetings in Cartagena. Hopefully many of the South American Countries will be present so that we can promote the intention and importance of unity within the FCI and that every member country should follow the regulations brought forward from these commissions.

During the year there has been frequent contact with the FCI office, and I thank Yves and his staff for excellent cooperation and help.

FCI COMMISSION FOR HERDING DOGS - Activity report



Herding working test and trial are open to sheep and cattle dogs of FCI groups 1, 2, 5. Sheepdog trials promote good handling of the sheep with a minimum of stress for them, as well as good handling of the sheepdog, to promote its will and working ability to secure and select the best working lines and to preserve the correct breeding of herding dogs.

In the past years the commission has drafted regulations for international trials. There are two kinds of regulations: collecting style for Border Collie and Kelpie, that follows fixed course, and traditional style open to all other herding breeds with courses which require more variables and follows the daily work of a Shepherd.

The regulations are recognised by the FCI and were published on the FCI website. At international trials the CACITR will be gained, which allows to obtain the title (CITR) Champion International de Troupeau.

Only some of the FCI member countries have recognised the regulations and published the international sheepdog regulations and (or) drafted similar national regulations.

The international situation concerning Border Collies is rather difficult as the UK Border Collies that work as herding dogs are registered in the ISDS studbook and also the trials are organised under the control of the ISDS. The ISDS Border Collie pedigree is recognised

by the Kennel Club if the Border Collie is bred in the UK. In some FCI countries some of the working Border Collies are double registered (FCI and ISDS) and many others have only ISDS pedigrees. As a result there is a conflict situation and in some countries a break between associations with lack of recognition and judge recognition too.

The commission expects some help from the FCI to support the working sheepdog, to make it grow and develop in more member countries under the FCI. Also in traditional style the availability of judges with experience is very limited and the discipline needs expert judges with good knowledge and training. The commission plans to organise meetings to be able to recruit more judges.

The commission had a meeting in May 2012 in Prague. The number of members of the FCI Commission for Herding Dogs is 18. There were only 7 people attending the meeting in Prague.

During the Prague meeting a new president was elected, as well as a new secretary. President: Luigi Guidobono Cavalchini from Italy, and secretary: Sandra von Erlach from Switzerland.

The next meeting will be held in October in Germany and will consider aptitude tests for herding dogs and the problem of training of judges and a calendar of international trial for collecting and traditional style.

FCI OBEDIENCE COMMISSION - Activity report

The special events of year 2012 have been the World Winner in Obedience competition in Salzburg, Austria in May and the judges' meeting in August in Hemer, Germany. The Obedience Commission's meeting was held in Stockholm, Sweden in August and excellently hosted by the Swedish kennel club.

The WW competition was very well organised and completed with an excellent routine. The number of nations and competitors interested in competing in the World Winner competition is increasing each year. This year we had teams from 19 nations and a full number of entries. Not everybody who had enrolled was able to start due to the restriction of 100 entries altogether. Japan had sent a team to Austria for the first time and they show great interest in joining FCI events. All in all the number of entries seems to increase. This will be a pleasant challenge to be dealt with in the near future. The judges of the WW competition were Johann Kurzbauer from Austria, who was also chief judge, Thomas Lundin from Sweden, Gianfranco Giraudi from Italy and Carina Savander-Ranne from Finland. The teams and the colleagues of Mr Johann Kurzbauer expressed their honour to him with a short ceremony at the end of the competition. This was the last time he judged at an international obedience competition having reached the age when judges have to give up judging international competitions.

A two-day judges' meeting was held in Hemer, Germany. The FCI Obedience Commission would like to thank the host for a very well organised meeting. In addition to a short presentation of the rules, the major time was spent on working with the dogs, assessing their performances and discussing and justifying given scores. As a result we became more acquainted with the cultural differences in assessing the exercises. However detailed and well written the rules are, we will always have our tacit knowledge present in our assessment.

FCI COMMISSION FOR RETRIEVERS - Activity report

The most important events in 2012 were the International Working Test (IWT) organised in Switzerland and the European Field Trial Championship held in Italy.

The IWT 2012 was arranged in Switzerland by the Swiss Retriever Club (Retriever Club Suisse). They had their own web-pages, http://www.iwt2012.ch where all entries were made electronically, and where the team members and fans could get updated information on the planning and find the results.

The IWT 2012 took place on the weekend of June 29th - July 1st on military terrains of the city Bière. The competition was judged by 5 well-know judges: Linda Partridge, Derrick Capel, Bob Stobbart and Robin Watson from Great-Britain and Werner Haag from Switzerland. Thirty-four teams from eleven countries made entries.

On Friday afternoon, the teams were welcomed at 'Hôtel de la Logeraie' in Morges, a hotel close to the test grounds.

On Saturday there were 5 tests. The weather conditions were really tough because of the heat. The judges were so kind and fair to adjust their tests to these unfavourable conditions. On the contrary the Sunday weather was rather fresh and rainy. The dogs also had to do 5 tests on the second day. No need to say that, due to 'better' conditions for the dogs, the distances of the retrieves were stretched. There were 5 tests on Sunday as well.

The Winner of IWT 2012 was Hungary national Team 1 with team members Csaba Karai and Int. FTCH Blackthorn Achenar, Robert Koszo and Real Gold Storm, Zsolt Torok and FTW Blackthorn Grus.

Number 2 was national Team Germany 2: Günther Köhler and Lockthorn Topper, Michael Zintl and Lost and Found Bo, Doris Albrecht and Dave von der Steinmauer. Number 3 was national team Italy 1: Chiara Berzacola with FTW Fame of Dukefield, Paolo Guardamagna with FTCH Eldorado, Salvatore Zappavigna with FTW The Growing Eric Emotion.

The Swiss organisation did a great job. Béatrice Loetscher, the chief organiser, and her crew really deserved all the compliments that were given.

The hosting country for 2013 will be Germany.

Every year a European field trial championship for retrievers takes place. In 2012 the Individual Retriever Championship (ICC, Individual Challenge Cup) was held in Italy on the well-known shooting grounds of Montodine. We had the pleasure of running our top event on grounds where shooting over spaniels, pointing dogs and retrievers is done regularly. The Italian canine organisation (ENCI) took up the heavy responsibility to organise this top event even though they also organised other major events during the same period. Thanks a lot to the ENCI. Stefano Martinoli, Italian FCI-delegate and seasoned retriever handler, did not enter any dog but ran the organisation. As chief steward and also shooting during the trial, he proved to be 'a man for all seasons'; well done Stefano!

For the first time ever, the ICC was organised as a twoday stake, which means that only one CACIT is granted at the end of the two days. So dogs and handlers have to perform on an excellent level for two days in order to obtain the CACIT and the title 'Winner of the ICC'.

Thirteen countries selected their best dogs and handlers. Eleven countries were represented by two dogs, Switzerland and Russia by one dog. So, twenty-four dogs at the start. The aim of the ICC is to rank the best dogs and handlers. As it is an individual competition, no ranking of national teams is made. Four judges were invited to judge this ICC: Stefania Gandolfi and Moira Frank Lanza from Italy, Declan Boyle and Damian Newman from Ireland.

During the two days birds were flushed by spaniels that had the courtesy of leaving them to the dogs in competition to be retrieved. More than once we witnessed very long retrieves and retrieves out of difficult cover. Dogs and handlers really had to show their abilities. Six combinations made it to the end of the second day.

The ICC on game and the International Working test on dummies were well organised. Dogs and handlers were tested in a fair and demanding way. Retriever people met each other in the way ... they want to meet each other.



The annual meeting of The FCI commission for retrievers was held on the 9th of November at The ENCI's premises in Milano, Italy where the ICC was held.

We welcomed the delegate for Czech Republic: Radim Kaspar. He gave us an interesting overview of shooting, hunting dogs and retrievers in his country. After a constructive discussion we mainly decided upon guidelines to select dogs for the international competitions (CdE, ICC, IWT).

The minutes of the meeting and the guidelines were sent to the FCI office.

The national delegates and myself would like to thank the FCI for the support given. We are also grateful towards the retriever community for giving us more than one good reason to keep on working.

"FCI international judges from federated FCI-NCO, will need confirmation prior to the event by their FCI-NCO to judge breed(s) and/or final competitions in the main ring abroad unless the FCI-NCO where they have their legal residence have their judges listed in the FCI (European Section) Judges Guide".

The proposal is turned down by the FCI board. However, the European Section and the members that have put their judges lists on the European Directory of Judges will be asked to indicate in it, if need be, that the approval of the FCI NCO is required.

Our second request was to send a letter to all FCI members where they are encouraged to include their judges in the FCI (European) judges Guide so that it may become a "FCI Judges Guide" where all FCI judges are listed.

The FCI board informed us that they had already informed the members in the European section and asked them to get in touch with the European Section. This proposal is therefore adopted. A letter is to be sent to each member of the sections that have not yet



adhered to the system and did not yet add their names to the Directory (it will also be referred to in the FCI Newsletter). Once this is the case, the Directory will be called «FCI Judges Directory».

During this year we were working on several items:

a. Trying to further extend the FCI European Judges List into a World List of Show judges. The FCI European Judges List keeps growing with more FCI members. It is also used by more and more organising committees and members to see whether judges are approved or not. Hopefully we will soon

be able to add all countries to this list.

- b. Rewriting and condensing our concept of a "Contract between the judge and the organising Committee of a show".
- c. Preparing the Powerpoint Model for the education "judging dog breeds". We are working on a basic model. We also wanted to develop a database for Powerpoints on dog breeding, but although we asked, we did not get any examples from our NCO colleagues yet. We need these to build up our digital "dog library". *Our basis model will* be presented during our next meeting in Cartagena in February 2013.
- d. We also discussed together with a member of the FCI Board – with The Kennel Club representatives the establishment of a framework for the mutual recognition of British Championship Show Judges and FCI International Judges. After several long discussions a final mutual recognition process based on training and education requirements for single and multi-breed judges, group judges and best in show judges was mutually agreed upon and proposed. This proposal has been sent to the FCI board.

- e. Developing a proposal for a basic statement for show judges to take into account the fact that a champion dog has to be fit for function.
- f. Our Chairman was asked to inform judges and the national canine organisation in China about the education programme for judges. We are happy to communicate with judges all over the world about their education and development in judging.

In 2012 the board of this commission consisted of:

- Horst Kliebenstein, President (Germany)
- Carla Molinari, Vice-president (Portugal)
- John Wauben, secretary (The Netherlands)

Our President, Vice-president and Secretary met twice this year. Several topics were discussed in the past year.

The year 2012 was also a year in which we were confronted with the fact that several countries did not respect nor followed or integrated the FCI decisions in their own national rules. Several countries disregard the changes in our rules and regulations and consequently do not follow them. We consider this to be undesirable, as rules and regulations are made to be followed by all the countries. On our agenda for Cartagena, there is a topic on this item.

We thank Yves De Clercq and his colleagues from the FCI Thuin office for the way in which our documents were at all times sent promptly and correctly translated to



our members and our thanks also go to the FCI Board member Tamàs Jakkel who supported and defended our proposals at all times.

2012 passed quickly. Another year in which social pressures on our dogs and on ourselves as show judges intensified considerably in many countries. We must jointly make a strong case for promoting fine but, especially, healthy, functional and social dogs as well, to ensure that cynology does not end in an irreversible downward spiral. That will have to be a basic theme of our discussions and concerns in the coming years.

Furthermore, the Commission decided to organise their future meetings in the weekend of the EC Coursing because of the major problems that consistently occur at these title events. The delegates have the perception that the Commission has to take a more active influence in these events.

At the EC Coursing 2012 in Hungary the problems were so comprehensive that it took until the meeting in Montde-Marsan to decide on the final classification in some breeds. The main problem is not just the high number of competitors, it is rather that national organisations overestimate themselves. It was decided that for the coming years the EC Coursing will be assigned to national organisations with a proven experience in the organisation of such large events.

In addition the existing checklist for the execution of the EC Coursing will be extended. The secretary of the Commission, Mr Henk Hendricks, will conduct this extension.

The next meeting will be on Friday 21.06.2013 in Greppin, Germany.

In The Haday

The FCI World Championships took place on 01-02/09/2012 in Mont-de-Marsan.

Mont-de-Marsan is situated south of Bordeaux and for the participants this is a long trip; together with the high fuel prices and the toll on the French motorways this may have been the decisive factor for a number of potential participants to abandon the trip.

For those reasons the number of entries was relatively low. Nevertheless, it was a well organised meeting with an excellent atmosphere among the attendants. In 2011, the Commission decided on a change in the practical execution of the races and reintroduced semi-finals in the run-up to the final. These semi-finals were highly exciting and the dogs that got through and qualified showed us thrilling finals.

FCI COMMISSION FOR SLEDGE DOGS - Activity report

In 2012 the FCI Commission for Sledge Dogs continued its work and met in Stockholm, Sweden on 2 and 3 June 2012. A perfectly well organised meeting thanks to the organisers and the Swedish Kennel Club, S.K.K.

The Commission was pleased to welcome four new Members: Germany, Norway, Russia and Slovakia and has now 14 Members.

The Commission reelected its Board. Mr Franco Mannato (France) was reelected as President, Mr Henrik Soeborg (Denmark) as Vice-president and Mrs Eveline Koch (Sweden) as secretary.

The Commission was also pleased to note that the document on "FCI guidelines for sled dog working judges " approved by the Commission at the 2011 meeting and forwarded to the FCI had been approved by the General Committee at its meeting held in November 2011.

During the period under review, the work of the commission focused mainly on the **discussion and drafting** of recommendations for international guidelines for the tests making dogs eligible to enter the "working class" in dog shows, as well as the delivery of CACT to enable dogs to become working champions, on a coherent basis.

New Members were in the position to explain their models for sled dogs draft tests and contributions from Germany, Norway and Russia were particularly interesting. However, while discussions were more interesting, the incorporation of new ideas brought by the new countries in the draft text took some additional time.

Guidelines under preparation take into account the two kinds of tests existing currently, the working test and the racing test. The working test is highly appreciated by all participants, but it only exists in Finland at the moment, while racing tests exists in many countries and need to be harmonised. Most discussions focused on the various problems faced by Member countries and how they try to solve them.

Discussions focused on the following problems:

- Age of dogs that can participate, as the minimum age varies from country to country;
- The exclusion from the racing tests for dogs that do not comply with the standard of their breed;
- The different levels applied to the racing tests that also vary from country to country; an agreement on two levels only, was finally accepted by all participants;
- Several technical annexes to the document were reviewed and modified.

A revised version of these guidelines will be discussed and possibly approved - at the next meeting of the Commission.

The next meeting of the commission is planned to be held on 1st and 2nd June 2013 in Denmark. Immediately after the meeting all decisions, and possibly the adopted document, will be forwarded to the General Committee for examination and, whenever possible, adoption.

FCI COMMISSION FOR UTILITY DOGS - Activity report

Meetings

Two meetings were held in 2012 (17.03.2012 and 24.09.2012 in Zalaegerszeg, Hungary), with delegates from FCI countries taking part. I would like to take this opportunity to thank all delegates who took part for their cooperation.

2012 FCI World Championships for Tracking Dogs

The 2012 FCI World Championship for Tracking Dogs was held on 18 - 22 April 2012 in Velten, Germany. I would like to extend my thanks to the organisation committee, with Mr Zdravko Klicek at the head of a team of colleagues. The dogs taking part in the Velten event, judged by Mr Juan López Pérez from Spain and Mr Aad Broekhuizen from The Netherlands, performed extraordinarily well. The event was held under the supervision of Mr Urs Meyer from Switzerland.

This year's FCI World Championship for Tracking Dogs saw dogs from 25 different countries competing. The title of 2012 World Tracking Dog Champion went to Mr Marco Dreyer with his German Shepherd Dog "Erik von Waliboer Land", gaining a total of 194 points.

Germany came out top of the 2012 country rankings, collecting a total of 382 points.

The following assessments were awarded: 1 excellent, 11 very good, 10 good, 1 satisfactory. 18 failed to pass.

2012 FCI European Championships for Tracking Dogs

The 2012 FCI European Championships for Tracking Dogs took place on 25 - 28 October 2012 in Ohlsdorf/ Gmunden, Austria. I would like to extend my thanks to the organisation committee, with Frans Raffelsberger at the head of a team of colleagues.

The dogs taking part in the Ohlsdorf/Gmunden event, judged by Mr Richard Straus from Germany and Mr Urs Meyer from Switzerland, performed extraordinarily well. The event was held under the supervision of Mr Bernard Roser from France.

The title of 2012 European Tracking Dog Champion went to Mr Erwin Patze from Switzerland with his German Shepherd Dog "Aly Hause Patzen", gaining a total of 194 points.

The following assessments were awarded: 1 excellent, 9 very good, 8 good. 1 failed to pass.

2012 FCI World Championships for Utility Dogs

The FCI World Championships for Utility Dogs took place in Zalaegerszeg (Hungary) on 20 - 23 September 2012, with 131 participants from 36 countries.

I would like to extend my thanks to the organisation team headed by Mr Biro Zsolt and Mr Atilla Marton. The preparations for this event took 2 years, and led to the event being conducted in an exceptionally orderly and conscientious manner. Both participants and spectators of this World Championship expressed their great satisfaction with the organisation.

The event was judged by Mr Rudi Krauer (Tracking) from Switzerland, Mr Robert Markschläger (Obedience) from Austria and Mr Igor Lengvarsky (Protection) from Slovakia. It was supervised by Mr Wilfried Schäpermeier from Germany.

The title of FCI World Utility Dog Champion went to Mario Versleypen from Belgium with his Belgian Shepherd Dog (Malinois) "Hascovan de Duvetorenl", gaining a total of 292 points. Germany won the team championship, gaining a total of 868 points.

Results: The following assessments were awarded: 4 excellent, 33 very good, 66 good, 6 satisfactory, 9 unsatisfactory. 2 dogs were ill and 11 disqualified.

Mondioring

The World Mondioring Cup was held in Grande-Synthe (France) on 28 Sept. - 03 Oct. 2012, with 55 participants from 19 countries.

The event was supervised by Ms Iris Remund from Switzerland.

Judges: Mr Valeer Linclau and Mr Jos Helsen (both from Belgium), the latter standing in for Mr M. Boisseau (France).

Commissioner: Mr Stefan Hubert.

The World Cup went to Mr Thierry Le Pellec (France) with his Belgian Shepherd Dog (Malinois) "BEP", who gained a total of 365 points.

The team event was won by Switzerland.

Comments on the balance sheet as of 31.12.2012

Assets

Fixed Assets

The item **"Land"** corresponds to the purchase value of the plot of land purchased in 2011 in Thuin.

The other Fixed Assets refer to net values after depreciation. The gross values (i.e. before depreciation) amount to 761,001 \in for property, plant and equipment (PPE) and to 130,072 \in for furniture and computer hardware.

Ongoing Assets (Work in progress) relate to the planning costs and fees already incurred for the new building.

Current Assets

The item **"Goods stock for resale"** covers inventories related to the FCI Centenary (Cobby, FCI Centenary Book, Agenda).

The item **"Trade Debtors"** consists mainly of outstanding amounts to be received from our members. The figure was reduced to a normal level in the course of the financial year.

The item **"Investments and cash money"** is greatly dependent on stock market developments (investments).



The land purchase also affected liquidity in the financial year. This can nevertheless be considered excellent.

Liabilities

The increase in the item "Accumulated Profits" corresponds to the external financial profits for 2012.

Statutory reserves for staff are recognised under "Affected fund for dismissal"; the defined objective is to have these grow - via annual subsidies - to reach the annual payroll amount; 2012 saw the sum of 100,000 € again being allocated to this account.

The increase in the item "Provisions" corresponds to the establishment of provisions of 15,000 \in in the financial year (reversal of the 10,000 \in provision for the 2011 anniversary and the inclusion of a new 25,000 \in provision for the 2013 General Assembly). See the Comments on the Profit and Loss Account

Passive Trade Debts decreased 132,000 € in the financial year to 40,000 €.

Comments on the Profit and Loss account

Operating Income

Revenues from international shows **(CACIB fees)** represent the FCI's main source of income; they reached approximately the same level as the previous year. The same applies to the other CACI entitlements and the kennel names.

The decrease in the item **«Miscellaneous»** under «Other operating income» is mainly attributable to the lower sponsoring revenues in the financial year in the aftermath of the 2011 centenary.

The item «Champion of Champions Brussels» has been removed in 2012, as this was a one-off occasion in 2011 (revenues from entry and entrance fees).

Operating Charges

The main factors contributing to the increase in the item **Remuneration** are certain necessary wage adjustments for staff and the associated expenditure on social security contributions.

The continuing shift from a printed version of the **FCI Magazine** to an **Internet** version has again led to a decrease in printing costs in 2012.

In years where a **General Assembly** takes place, the annual financial statement also includes the effective costs for the GA (2011). In the interim years, provisions are set aside.

The decrease in expenditure for meetings of the **General Committee and the mandatory commissions** can be attributed to the lower number of meetings in the years in which no General Assembly is held. Expenditure on **Legal and accountancy fees** relate to our accounting and auditing firm and to our lawyers. We did not have to consult them as often as in the previous year.

The decrease in expenditure for **«Translations, Marketing, Internet»** is mainly due to the lower expenditure associated with contracting out translations. Furthermore, the costs for «Internet design and maintenance» were lower than in the previous year.

The item «Other operating charges» combines several expenditure items, which together increased by a total of $34,000 \in$. It includes expenses for the ad-hoc commission «Back to the standards».

The expenditure on «FCI Centenary Celebrations» combines all costs incurred for the centenary events in the previous year (Symposium, Champion of Champions, Gala Evening, etc.). This expenditure was completely offset by the provisions set aside in the previous years and contributions from sponsors. A small number of invoices related to the centenary were paid in the course of the financial year.

The 15,000 € set aside as provisions relate to the following: Centenary year: -10,000 €; General Assembly: +25,000 € and corrections for goods stock 11,000 €.

Operating profit amounts to 136,000 € (2011:259,000 €).

Financial income includes the value adjustments in the securities portfolio as well as earnings from securities and liquid assets.

The result for the year amounts to 104,000 \in (2011: 215,000 \in).

REPORT TO THE FCI GENERAL ASSEMBLY ON THE ANNUAL ACCOUNTS FOR THE FISCAL YEAR ENDING 31 DECEMBER 2012

Pursuant to the request of Mr DE CLERCQ, Executive Director of the FCI, we submit our report in our capacities as external auditors.

We audited the annual accounts for the fiscal year ending 31 December 2012, drawn up based on the fundamental accounting principles as applied in Belgium, for which there is a balance sheet total of \notin 3.996.734,85 and for which the profit and loss account shows a profit for the year of \notin 104.030,49.

Our responsibility is to give an opinion on these annual accounts based on our audit. We executed our audit in compliance with the legal provisions and in accordance with the auditing standards that are applied in Belgium, as decreed by the *Institut des Reviseurs d'Entreprises*.

These auditing standards require that our audit be planned and executed to obtain reasonable assurance that the annual accounts do not have any significant anomalies, whether they result from fraud or from error.

In accordance with the above-mentioned auditing standards, we took into account the Federation's administrative and accounting organization as well as its system of internal control. We obtained the explanations and information we needed for our audit from the Federation's managing body and its officers. We examined, on a test basis, the evidence supporting the amounts that appear in the annual accounts. We assessed the accounting policies used and the reasonable nature of the significant accounting estimates made by the association as well as the overall presentation of the annual accounts. We believe that the audit provides a reasonable basis for our opinion.

In our opinion, the annual accounts for the year ended 31 December 2012 present fairly the assets, the Federation's financial position and its results of its operations in conformity with the general accounting principles as applied in Belgium.

Letter of Understanding between FCI and AKC

WHEREAS the Fédération Cynologique Internationale (FCI) and The American Kennel Club (AKC) share the common goals of promoting and protecting purebred dogs; and

WHEREAS the parties hereto have in the past cooperated to a certain extent in carrying out this object and have been acting pursuant to certain informal agreements made from time to time for that purpose; and

WHEREAS it is agreed that the relations between AKC and FCI and its member registries should be explicitly written with a view towards future cooperation;

NOW, this letter of understanding encompasses the mutually agreed to basis for the relationship between the parties as follows:

- AKC will recognize the pedigree for any FCI registry that meets AKC requirements and that wishes to have such recognition.
- AKC will not automatically give exclusive recognition to the FCI registry in any country in which there are multiple registries and FCI will not automatically give exclusive recognition to AKCs registry in the United States.
- 3. AKC will not register any dog born in an FCI member country until that dog has been registered in the Stud Book of the FCI registry or the AKC-recognised registry in that country. No dog born in the USA, belonging to breeds recognised by the AKC, will be registered by an FCI member registry unless the dog has been registered in the FCI-recognised registry in the United States. It is up to the FCI to decide about the registration of dogs born in the USA belonging to breeds not recognised by the AKC.
- 4. Each of the parties agree that when any information comes to its knowledge which might reasonably affect or be useful to the other party (AKC judges suspension, amended standards, etc.), it will immediately communicate such information to the other party.
- FCI and AKC will deal with the judging approval reciprocity in a separate document (see attachment).



- 6. AKC will not sponsor any event in the country of an FQ member without the express permission of FQ and the FQ member. FQ will not sponsor any event within the territory of the United States without the express permission of AKC. Puerto Rco is exempted from this provision as both AKC and FQ have been previously sponsoring activities on that island.
- 7. While not an FQ member, FQ has graciously agreed to permit AKC to participate in its World or Section Agility, Utility, Obedience, etc. Championship Championship Event provided that this participation does not prevent representative teams of FQ member organisations from taking part. If the AKC teams win the competition, they are not eligible for the title of FQ Winner at these events.
- 8. AKC registered dogs are eligible for the title of FCI International Champion under specific conditions to be agreed upon by the AKC and FCI.
- 9. Except with the agreement of the AKC, the FCI will not register kennel names for breeders living in USA (with exception of Puerto Rico) and, except with the agreement of the FCI, the AKC will not register kennel names for breeders living in countries where the FCI has a member, which the AKC has accepted.
- 10. FO agrees to send to the AKC headquarters all revised breed standards and AKC agrees to send to the FO headquarters copies of its Complete Dog Book, which includes all AKC standards, each time that such publication is revised.
- 11. The terms of this letter of understanding is agreed to by the parties listed below. This agreement may be terminated by either party upon reasonable notification to the other party.

Breed Judging

At FCI CACIB international shows, the AKC judges are eligible to judge and award the CACIB provided that the two following conditions are fulfilled:

- the breeds they are scheduled to judge are recognised by the AKC (this does not include FSS and Miscellaneous classes).
- the judges in question are allowed to judge, under AKC regulations, the breeds in question at AKC events and award them championship points. An AKC judge, residing in the United States, may not be approved as an FCI judge (breed, group, all breed) eligible to award CACIB.

At AKC events, the FCI judges are eligible to judge and award championship points provided that the following conditions are fulfilled:

- the breeds they are scheduled to judge are recognised by the FCI and by the national kennel dub, in their country of residence, which has jurisdiction over the judges in question
- the judges are members of their national kennel dub, in their country of residence, which is an FO member or contract partner
- the judges in question are allowed to judge, under FCI regulations, the breeds in question at FCI International CACIB shows and award them the CACIB

Group and BIS Judging

It is up to both, the AKC and the FCI members, to choose to invite or not a judge to judge a particular group (according to FCI or AKC breed nomenclature) at an AKC event or at an international FCI CACIB show taking into consideration the experience of the judge, his judging credentials and the breeds and their numbers in the groups to judge.



Letter of Anderstanding between the Fédération Cynologique Internationale and the Kennel Club

WHEREAS the Fédération Cynologique Internationale (FCI) and the Kennel Club (KC) share the common goals of promoting and protecting, in the case of the FCI, pedigree dogs and in the case of the Kennel Club, all dogs; and

WHEREAS the parties hereto have in the past cooperated to a certain extent in carrying out this object and have been acting pursuant to certain informal agreements made from time to time for that purpose; and

WHEREAS it is agreed that the relations between KC and FCI and its member registries should be explicitly written with a view towards future cooperation;

NOW, this letter of understanding encompasses the mutually agreed basis for the relationship between the parties as follows:

- The KC, where it recognises the breed in question, will recognise the pedigree
 of any FCI registry that meets KC requirements and that wishes to have such
 recognition.
- 2. In so far as it is lawful, the KC will give exclusive recognition to the FCI registry in any country in which there are multiple registries provided that these registries meet KC requirements and the FCI will give exclusive recognition to the KC's registry in the United Kingdom. For the time being this will not include Malta and China.
- 3. The KC will not register any dog, or issue a pedigree to any dog, born in an FCI member country whose registry the KC recognises, until that dog has been registered in the FCI registry in that country. No dog born in the UK will be registered, or have a pedigree issued, by an FCI member registry unless the dog has been registered by the KC in the United Kingdom.
- 4. Each of the parties agree that when any information comes to its knowledge which might reasonably affect or be useful to the other party (KC or FCI judges suspension, amended standards, etc.), it will immediately communicate such information to the other party.
- 5. The FCI and the KC will endeavour to agree on the conditions to make their respective judges eligible to officiate at events sanctioned by them (FCI and KC).
- 6. The KC will not sponsor or support any event for dogs in the country of a current FCI member without the express permission of the FCI member. The FCI will not sponsor or support any event for dogs within the territory of the United Kingdom without the express permission of the KC. For the time being this will not include Malta and China.



- 7. While the KC is not an FCI member, the FCI has graciously agreed to permit the KC to participate in its World or Section Agility, Utility, Obedience, etc. Championship Event provided that this participation does not prevent representative teams of FCI member organisations from taking part. The KC teams may win the competition but are not eligible for the title of FCI Winner at these events.
- The FCI agrees to send to the KC headquarters all revised breed standards and the KC agrees to send to the FCI headquarters copies of all revised breed standards. The FCI and KC will discuss health issues connected with breed standards on a regular basis.
- FCI members are allowed to refer to the title of UK Champion by using the abbreviation "UK Ch + name of the dog".
- 10. Except with the agreement of the KC, the FCI will not register kennel names of breeders living in the UK and, except with the agreement of the FCI, the KC will not register kennel names of breeders living in countries where the FCI has a member, which the KC has accepted.
- 11. The terms of this letter of understanding are agreed to by the parties listed below. This agreement may be terminated by either party upon reasonable notification to the other party.

Memorandum of Understanding between FCI and CKC

WHEREAS the Fédération Cynologique Internationale (FCI) and The Canadian Kennel Club (CKC) share the common goals of promoting and protecting purebred dogs;

WHEREAS the CKC and the FCI have, in the past, cooperated to a certain extent in carrying out these goals and have been acting pursuant to certain informal agreements made from time to time for that purpose;

WHEREAS it is recognized that both the FCI and the CKC are required to operate within the limits of the legislation governing their activities, including their respective constitution and by-laws;

NOW this letter of understanding expresses a mutually agreed to basis for the relationship between the CKC and the FCI as follows:

- The CKC acknowledges the role of the FCI and its governing institutions as set out in the FCI Statutes as the primary world federation of dog registries.
- 2. The FCI acknowledges the CKC as the primary kennel club in Canada.
- The CKC and the FCI agree that when any information comes to the knowledge of one party, which might reasonably affect or be useful to the other party (judges suspension, amended standards etc.), it will immediately communicate, in writing, such information to the other party.
- The parties will meet at the request of either of them, within a reasonable timeframe and on basis of a consistent mutually agreed agenda which will include matters of common interest.

- 5. The FCI agrees to send to the CKC head office a copy of all breed standards with revisions as they occur and CKC agrees to send to the FCI headquarters all CKC breed standards with revision as they occur. The FCI and CKC will also share information concerning the decisions of their respective governing bodies such as the exchange of official publications.
- 6. The CKC will periodically provide the FCI with a list of the registries from the FCI member countries with which the CKC has reached an agreement providing for the mutual recognition of studbooks and pedigrees. The CKC will get in touch with all the FCI members and contract partners and inform them about the procedure to follow to gain CKC recognition. The FCI will notify the CKC of the accession of any country to FCI membership.
- The details of a mutual recognition of FCI and CKC judges are written on a document which is part of this contract.
- The FCI will not sponsor or sanction any event within Canada without the express permission of the CKC.
- The CKC will not sponsor or sanction any event in an FCI member country without the express permission of the FCI and the agreement of the member country.
- 10. While not an FCI member, FCI graciously agrees to permit CKC to participate in its World or Section Agility, Utility, and Obedience Championship Events and any forthcoming canine performance event that may be mutually recognized by both organizations.
- 11.As long as no agreement is reached with regard to the working breeds (according to the FCI nomenclature) between the FCI and CKC, these breeds (CKC-registered dogs) are not eligible for the title of "International Beauty Champion". The non-working breeds (CKC-registered dogs) are eligible for this title provided that they comply with the FCI International Championship Regulations, i.e. 4 CACIB in 3 countries under 3 different FCI judges.
- 12. The CKC registered dogs are eligible for the other FCI international titles provided that they meet with the FCI requirements.
- 13. The FCI international directory of kennel names (affixes) is not open to CKC breeders and the FCI cannot guarantee that a CKC kennel name (affix) will not be similar to an FCI registered kennel name (affix) and conversely.

- 14. Both parties agree that the present Letter of Understanding shall not be interpreted or applied so as to require either party to act in a manner not authorized by or contrary to applicable legislation, including each party's constitution, rules or by-laws.
- 15. The terms of this Letter of Understanding are agreed to by both parties. This agreement may be terminated by either party upon giving the other party 60 days notice in writing.

CKC Judges eligibility to officiate at FCI International Events

From April 1st, 2009, the following dispositions will apply:

- a) CKC judges are allowed to judge in the FCI member countries all-breed, group and specialty national shows, the breeds they are approved to judge in Canada.
- b) CKC judges who have already judged international FCI CACIB shows before December 31st, 2007, are allowed to award CACIB at international FCI CACIB shows, FCI World and Sections shows, to the breeds they are approved to judge in Canada.
- c) Once a CKC judge has judged four (4) national shows in four (4) different FCI member countries by the FCI breed standards, he/she is allowed to award CACIB to the breeds he/she is approved to judge in Canada.

It will be the responsibility of the FCI Office and of the judges concerned to keep track of assignments undertaken in an FCI member country. Taking into account the legal restrictions on the exercise of extra-territorial jurisdiction by the CKC, it will be the responsibility of the CKC to communicate them to their judges and the practical implementation and enforcement of the agreed above principles will be under the responsibility of the FCI Office, of the FCI members and the judges concerned.
