We are making sure that all of our members' best interests and concerns are being heard, analysed and discussed. A rapidly changing world compels us to protect our organisation, fiscally and morally. I take this opportunity to thank my colleagues at the FCI General Committee and the FCI for their commitment and passion for the future and well being of our organisation and most importantly for our dogs. # **Mission Statement**

#### Introduction

In accordance with the celebration of the 100 Anniversary of the Fédération Cynologique Internationale, the General Committee of the FCI reviewed its Mission and Vision Statements and Values to maintain our leadership worldwide.

#### **Mission statement**

The FEDERATION CYNOLOGIQUE INTERNATIONALE (FCI) is the supreme authority of the canine culture worldwide. The FCI is responsible for safeguarding canine health and international dog activities to enhance the relations between dogs and humans. Established in 1911 the FCI includes 92 members and contract partners (one member per country). Each member issues their own pedigrees and train highly qualified judges. The FCI makes sure that the pedigrees and judges are mutually recognised by all the FCI members, contract partners and any person involved in their domestic canine scene.

#### Vision statement

The FCI supports, via its members and contract partners, the well-being of all dogs Worldwide.

#### Values

- THE FCI cares about all dogs worldwide.
- THE FCI considers the health, temperament and behaviour as the most important matters in dogs and their Breed Standards.
- THE FCI promotes dog activities and dog sports worldwide, which it considers beneficial to the dogs.
- THE FCI entrusts its commissions to make recommendations about other important matters.
- THE FCI divides geographically the world of dogs through its five sections.
- THE FCI trusts its members and contract partners to protect the integrity of their National Registries.
- THE FCI recognises and respects agreements with nonmember national organisations.
- THE FCI sets the highest standards for its headquarters.
- THE FCI ensures the regular celebration of World and Section Championship events.



The Dog World does miss them: U. Fischer, honorary FCI Board member, Manuel Lourero Borges, Portuguese all-breed judge, Gert Christensen, Danish all-breed judge and Enrique Filippini, Argentinian all-breed judge, Bo Jonsson, former and longstanding President of the FCI Obedience Commission and Tibor Gellen, MEOE judge. There may be more for which we were not notified and I apologise if I fail to mention them! May they all rest in peace!

Globally, 2016 was a good year for the FCI if we take a look at the international activity of our members and contract partners.

With a total of 1,206 international CACIB shows (vs 1,096 in 2015), the number of those events keeps increasing and follows the trends that we have observed over the last decades. The FCI Office confirmed more titles of Int.Ch than ever: 9,722 in total (beauty and working)! Accurate figures about the total entry at shows or the number of CACIB confirmed are not yet available as the FCI Office is still processing many 2016 show results.

Our members organised a total of 2,426 trials (all disciplines together), slightly higher than in 2015.


Finally, to end up with statistics, the FCI registered an amazing number of 23,199 kennel names applications (vs 18,849 in 2015).

Different activities were held in the frame of our official title "Thuin, World Capital of Dogs": considering the success obtained in 2015, we organised once more a "Canine Walk" in the vicinity of our city. Dog owners loved it and it was another great achievement of which we can be very proud. It helps us strengthen our rooting in our home town.



We also had an interesting conference held at the new FCI Offices about the Perro Sin Pelo del Perú, with a nice presentation about this yet-to-be discovered breed.





We were happy to share our new museum with different visitors all year long. This nice room raises interest among people and it's always a pleasure to have visitors at the FCI Office.



Finally, in September, for the first time ever, we organised the so-called "Cynothon" in a neighbouring city, Montignyle-Tilleul. Once again it was a huge popular success with the presence of some representatives of the French canine organisation (SCC). Dog owners and their dogs had the opportunity to wander in the nice countryside of our region.







Last December, taking advantage of the visit of our President at the FCI Office, we invited our long-standing local partners for a X-mas cocktail. Representatives of the City Hall, of the Press, members of the Tourism Office, Mr JL Ibáñez from Eukanuba and representatives of the Pet Protection Society of Charleroi joined us.



Other important meetings took place at the new FCI Headquarters: the Executive Committee met representatives of the Australian National Kennel Council, the FCI President met




l also want to insist on some important agreements or decisions taken during the year 2016.

The FCI signed an agreement with Brussels Airlines and the Lufthansa Group which gives a discount on a huge number of flights for those who could enjoy it. It's my pleasure to inform you that the agreement will be reconducted in 2017.

A very important circular ruling the participation of cropped and docked dogs at FCI events was issued, clarifying the FCI position. The FCI General Committee listened to all parties involved and took a wise decision.

Another important step was the launch of the official Anti-Yulin campaign with badges and stickers produced and distributed at our major shows in order to show the fierce opposition of the FCI against this canine slaughter.





My warmest thanks to the FCI General Committee members, the FCI members and all the presidents of the FCI commissions for their good cooperation.

As you can all see, we can definitely call 2016 a "great year"!



### FCI SCIENTIFIC COMMISSION – ACTIVITY REPORT

#### President: Dr Kirsi Sainio Members: Prof. Åke Hedhammar, Dr Andreas Villalobos, Dr Margarita Durán, Dr Grégoire Leroy

The FCI Scientific Commission has faced an unusual situation since the year 2015 left the Commission without a President. This was due to the unfortunate circumstances that made impossible the re-election of our former President, Professor Zeev Trainin, at the General Assembly held in Milan. The work of the commission was paralysed after the extraordinary Commission meeting in Thuin in November, 2015. After this meeting, one member was missing, as well as the President. Prof. Trainin was proposed by the member of the Commission to be named as a "senior advisor" for the Commission. This issue has not been fully resolved today.

During the meeting the Commission was nevertheless able to finish the procedure of recognition of one new breed, the Lancashire Heeler (FCI Standard number 360). The breed was accepted on a provisional basis in May, 2016. The Commission also dealt with the application of the two new Czech breeds, namely the Chodsky Dog and the Prazsky Krysarik Dog. Their population statistics still required more detailed information, and the issue will be on the agenda at the meeting in Paris, in 2017.

The new President was elected by the remaining members in a vote conducted by the FCI office. Dr Kirsi Sainio was elected as the new President in February, 2016.

Unfortunately, a few members of the Commission were unable to attend the Scientific and Standards Commissions meetings that had been planned to be held in Mexico in April, 2016 after a kind invitation of Federación Canófila Mexicana. The Scientific Commission's meeting was thus cancelled. The next meeting will be held in Paris, in April 2017, during the 3rd Dog Health Workshop organised by the Société Centrale Canine (France). There is a reasonable hope that the Commission is able to continue its important work.

In the meantime, the Commission has not been idle. Dr Grégoire Leroy was in Moscow during the 2016 World Dog Show and conducted the examination of the Russian Toy Dogs, together with a member of the Standards Commission. The final recognition of the breed will be on the agenda of the Commission for our next meeting. Dr Leroy has also been busy assessing the family groups of several new breeds that seek for FCI recognition. All these breeds will be assessed in the meeting to come.

The Commission has published several articles and presentations on the FCI website. Prof. Trainin and Dr Leroy published an article: Dog breeding and molecular tools: uses and concerns; Dr Villalobos an extensive presentation, also available as a PowerPoint presentation: Enfermedades hereditarias y congénitas. This important work still needs to be translated into English. A new model for FCI Hip-/Elbow Dysplasia International Certificate was also published. This certificate can also be used by the national canine organisations.

The President of the Commission, Dr Kirsi Sainio, has been busy answering several questions and inquiries coming from the members, the FCI national canine organisations, but also from individuals that have been concerned about a certain health or genetic issue in dogs.

All this has only shown that the Scientific Commission's work is important and that we absolutely need this Commission in the future as well. The work of the Commission is still facing challenges, but - I am convinced - nothing that we could not overcome for the sake of our dogs.

We had a very warm welcome from the hosts J. L. Martinez and Dr Andrés Villalobos (Mexico) whom I want to thank in a very special way for all the work that they carried out to prepare our meeting and all the attentions they had for us.

The meeting took place at the Hotel Live Aqua Cancun which our guests reserved for us.

The FCI Standards Commission's main work being to revise and adapt new and existing standards is constant. The focus on dog's health continues to cause countries to review the text in standards extra carefully to avoid wordings that may result in interpretations that can lead to exaggerations that might cause health risks in the dogs.

The Commission continuously amends or thoroughly revises standards and the co-operation with the member countries is usually efficient. Still, the procedure has to go through several steps before a standard can be published, and rightly so as these documents are the backbone in the work of the FCI and its member countries.

Viewing of the text in standards from a health and welfare perspective is intensified. This is not always to the liking of the countries of origin, but in the interest of keeping the breeds for the future, we all have to realise that exaggerations in type as well as character issues in guard dogs might not only jeopardise the health of the dogs, it may also increase the risk to have breeds banned by law.

We tried to mark a working method within the commission; how to manage the standards since they arrive to the office until they are seen and discussed by the commission and send back to the FCI General Committee. Amended or re-worded standards

We revised the standards belonging to the Kennel Club.

Standards of Irish breeds were received with an annex of the main points to give special attention to; we sent them back, underlying which points should be in the standards and not in the annex.

Interra's request to judge separately the Russell terriers wire and smooth was accepted.

The next meeting will take place in the same dates of the Third Dog Health Workshop, in April 20th and 21st 2017, in Paris.

I would like to thank my colleagues for the friendship and good work in the Commission. I also want to thank the FCI Scientific Commission, as well as the staff at the FCI General Secretariat in Thuin for the excellent collaboration, and the General Committee for their support.

### FCI BREEDING COMMISSION - ACTIVITY REPORT

The annual meeting of the FCI Breeding Commission was arranged in Olso, May 28th, with the excellent hospitality of the Norwegian canine organisation.

Representatives from the following members were present at the meeting: Margit Brenner (Austria), František Nahodil (Czech Republic), Birgitte Schjoths (Denmark), Janne Orro (Estonia), Ruth O'Connor (France), Maria Ceccarelli (Italy), Inga Cerbule (Latvia), John Wauben (The Netherlands), Astrid Indreboe (Norway), Elzbieta Augustyniak (Poland), Luis Gorjão-Henriques (Portugal), Svetlana Nazarikhina (Russia), Rafael Malo Alcrudo (Spain), Annica Uppström (Sweden), Yvonne Jaussi (Switzerland), Olena Skliarova (Ukraine).

The following guests also attended the meeting: Mr Leschenko and Mrs Gladkikh (Russia), Mrs Renata Berlinska (Poland) and Mrs Kim Bellamy (Norway).

The Secretary for the Commission was Dr Janne Orro.

The President, Dr Astrid Indrebø, decided to leave her position and the meeting began with elections. There was one candidate to each position and there was no voting as decision was made consensually; new president, vice-president and secretary were named as follows: President: Luis Gorjão-Henriques; Vice-president: Maria Ceccarelli and Secretary: Janne Orro.

The following issues were discussed:

Type of coat, colour and size should be added in the threegeneration pedigrees, including export pedigrees.

This is of uttermost importance, especially in the case of crossbreeding between closely related breeds and varieties.

This proposal was approved by the General Assembly and written down in the Standing Orders, but some members are still not following it. The FCI Breeding Commission asked the General Committee to make a circular to be sent to all members, with a possible transtition period and the deadline from which this decision starts to be compulsory. Although varieties and coat types are easy to identify on every pedigree, colours are more difficult to describe in a uniform way.

As it is not possible to create a transition period for the countries that cannot follow this rule at the moment -the rule is effective from the date of the General Assembly- the proposition was turned down.

It was also suggested that the BC should ask that the Scientific Commission makes a Code table with accepted colours and



genetic code to be distributed to all NCO in order to be used on pedigrees and Export pedigrees. This table of colours will have the scientific description of the colour and the breeds in which it is accepted, so no pedigree will be issued with wrong colours. There is a need for a standardised nomenclature of coat colours as it is now required to write the coat colours on the pedigrees. The NCOs are using different descriptions.

The FCI Breeding Commission asks the General Committee to turn to the Scientific Commission to make a table with colour codes (for pedigrees and export pedigrees).

#### GC decision October 2016

The idea was found interesting by the GC, and is appreciated. The matter will be referred to the FCI Scientific Commission. The GC drew the attention on the curious division of the colours in Pug (the correct distribution for CACIB should be Black and Fawn, only).

Registration of imported dogs that would have been registered with limited registration (not allowed for breeding) if they were born in the country to which they are imported (amendment in the FCI Standing Orders)

This was approved by the GA, and added to the Standing orders, but the FCI Breeding Commission feels that a circular should be sent on this subject to all FCI members.

Each dog of a litter has to be provided with only one pedigree and only one export pedigree, which must include the name of the owner of the dog; if the owner's name is not written on the pedigree, a separate owner's certificate must be issued by the national kennel organisation. This was approved by the GA, and added to the Standing orders, but the FCI Breeding Commission feels that a circular should be sent on this subject to all FCI members.

FCI should take actions against the new EU law that does not allow each country to decide that puppies less than 3 months can be imported from just some EU countries (free of rabies); the new law says that if a country allows import from some EU countries, they have to allow import from all EU countries.

- According to the new rule, EU does not permit to discriminate between countries regardless the situation of contagious diseases; the same rules must be valid for all countries.
- It is of major importance for the organised dog scene in Europe that FCI now takes action in this matter, to help dog breeders and dog owners in Europe, and to show the members the strength of FCI as a the largest dog organisation in the world, working for dog welfare and genetic diversity in pedigree dogs.

The FCI Breeding Commission felt that the proposal to FCI European Section should be done once again. We do understand that each country can make its own decision to enforce or not this decision of the EU, but FCI should ask the European Union that when to impose such a rule, there must be an exception for FCI pedigree dogs.

#### GC decision October 2016

FCI European Section indicated that it's a European Section matter, which is being taken care of.

#### Guidelines regarding criteria for limited registration

Proposal to the FCI General Committee should be done once again. We do understand that FCI should not have too many rules, but what we are proposing are just guidelines. The FCI Breeding Commission understands the General Committee's reluctance to impose and implement more regulations. BC's proposal, however, is made with the goal to recommend and educate. As background information, BC was again approached by several NCO's delegates asking for recommendations on how to use limited registration. BC understands that NCOs may differ in how they use and implement regulations. The guidelines for limited registration are offered for information and education for those NCOs that need it.

#### GC decision October 2016

The GC reiterated its opinion, communicated at the meeting held in Zagreb in 2015.

#### White Swiss Shepherd Dogs

It was noted that a lot of countries do not follow the FCI circulars from 2007 and 2013 which state that it is not allowed to use dogs with German Shepherd Dogs in their 3-generation pedigrees. Genetic diversity is needed and as stated by Dutch statistics of the Raad van Beher, 74% of their WSS would have to be taken off the breeding pool if the circulars were followed. For the same reason, most countries do not apply FCI's circulars. The FCI Breeding Commission has decided that Swiss NCO will have a meeting with the concerned NCOs before October. The Netherlands, France, Italy, Russia and Germany should be involved in this meeting. The FCI Breeding Commission. From this meeting a decision can be addressed to the FCI.

#### GC decision October 2016

The General Committee will wait for the outcome of that meeting before taking any further decision.

# «Breeding for function» presentations and discussions on that subject

#### The Brachycephalic syndrome / BOAS

The FCI Breeding Commission would like the following sentence to be added to all standards of all breeds: "The length of the muzzle in relation to the skull should be at least 1:2 (measured respectively from the tip of nose to the inner corner of the eye to occiput)."

The FCI Breeding Commission asked the General Committee to refer the subject to the Scientific Commission and the Standard Commission to work out a general rule to be applied to all breeds concerning the minimum length of the muzzle compared with the length of the skull, to prevent brachiocephalic obstructive airways syndrome (BOAS). This proportion is not just a mere opinion of some but is the result of scientific studies made by NKK with the cooperation of SKK, with a written paper on this subject. The FCI Breeding Commission considered by majority that the above sentence should be added to all breed standards. FCI should also spread the idea that "FCI pedigree dogs are health-screened" and that "we care for the health of dogs, while no-pedigree dogs cannot be controlled".

#### GC decision October 2016

The GC believed that the above proposal does not apply to all breeds and that it is against the rights of the countries of origin. This matter needs to be discussed within the Standards and Scientific Commissions.

#### Breeding for longevity

There was a request for volunteering to prepare a presentation about breeding for longevity. The delegate from Switzerland explained that this is a difficult subject as various aspects are affecting longevity and it is controversial whether very long age necessarily means good quality of life. This subject will be worked out at the next meetings.

Proposal from Spanish delegate about special prize / title for dogs in the veteran class: the presentation of Veteran dogs at dog shows with more awards and titles and separate classes for the Veterans and the older Veterans should be promoted worldwide. The more these older dogs are shown, the better we can spread the idea that pedigree dogs can live long and healthy until old ages, as the general public has the opposite perception.

# Registration of puppies in the studbook of a country different from where the breeder lives

FCI should send a reminder to its members that NCOs have to obey Breeding Regulations and the FCI Standing Orders. Pedigrees for dogs from unrecognised organisations should not be certified as FCI official pedigrees.

#### International Partnership for dogs 3rd International Dog Health Workshop

The FCI Breeding Commission urged the NCOs to send committee members to participate on the Dog Wealth Workshop in Paris.

# How to handle an outcross programme when the country of origin is still doubting

There are 2 examples from the Netherlands:

- a. A breeder mated a Griffon Bruxellois with a Border Terrier. One of the Dutch breed clubs wants to develop a plan of action for more outcrosses. How to handle that when the country of origin doesn't agree?
- b. One of the Dutch breed clubs wants a crossbreeding programme for Irish Wolfhounds with Alaskan Malamute in order to widen the gene pool and improve the health. The country of origin is strictly against.

**Conclusion of the Breeding Comission:** Any crossing between unrelated breeds should be based only on scientific evidence, with health, genetic diversity and conformation proof that it should be done. All dogs resulting from these crossings should be registered with the appendix studbook. Only crossing allowed by the FCI circular can be performed,

and any other crossing should be presented to the NCO of the country of origin of the breeds in question.

#### Ethical discussion about double mating

The topic was also sent to us by the Netherlands, and the delegates were asked to inform about the situation in their country:

What countries have rules for this? What are your rules?

The following is stated in FCI International Breeding Rules: Art 18 (last paragraph): "Pedigrees, which are in fact birth certificates, must be issued for correct parentage only. Normally, a female is to be mated by only one male for the same litter. In cases of deviations, the kennel clubs are obliged, at the breeder's cost, to have the parentage proved by DNA testing."

*Conclusion of the FCI Breeding Commission:* Double mating can be accepted, but it should also be done with previous request by the breeder and authorisation by the NCO. No more than two different males should be accepted for one and the same mating.

#### **Designer Breeds**

*Conclusion of the FCI Breeding Commission:* Overall conclusion is that we do not need more breeds! There are established rules

for the recognition of new breeds, Annex 1a) of the Standing Orders, and Designer Breeds do not meet them.

Unaccepted colours resulting from the crossing of breed varieties can only be accepted in the appendix studbooks or with a limited registration.

#### HD screening

HD screening results seem to be worse in Scandinavia: are Scandinavian requirements more severe?

The FCI Breeding Commission asked the General Committee for the Scientific Commission to organise a Conference between all official X-ray readers in order to have the same criteria, which do not change from one country to the other or from one official reader to the next one. FCI should promote this conference.

#### GC decision October 2016

The matter will be referred to the FCI Scientific Commission. The last similar conference was held many years ago in Copenhagen and many new vets are now involved in the dog world. It would be good to give them the opportunity to be updated.

This commission also worked on establishing other important issues for the sport, like the regulations for an international judges list and the extent to which guidelines should also be set for the organisers of international championship competitions. The commission was unanimous on putting extra emphasis on the health and well-being of dogs in our sports, and that this should also be visible in the future rules.

The FCI Commission for Dog Dancing has also already helped in settling some international disputes. All in all, the role of the FCI Commission for Dog Dancing has, in 2016, through its work become increasingly visible to the public in our sport, and there has been a fair amount of interest in this commission's work throughout the year.

# FCI COMMISSION FOR FLYBALL - ACTIVITY REPORT

First goal for any FCI Commission for Flyball is always to get all noses to point in the same direction, which is never obvious. Once everybody can agree on a unanimous line, most countries see the opportunity of generally approved guidelines and regulations. For the first two meetings in 2014 and 2015, the Commission tackled the national differences in the applied rules and – after long discussions – agreed on a united set of rules for international flyball. The next hurdle for 2016 was to decide on the specifications for a very first international tournament for flyball.

Nevertheless, at the start of the Commission's meeting in Prague (CZ), it turned out that especially the method of measuring in the new rules was not completely clear for all countries. Therefore, we started with outlining a clear document titled 'recommendation on method of ulna measuring' were the method was clearly described. This document will be published on the FCI website to avoid any kind of misunderstandings on the method.

For the international tournament, the Commission decided that an individual World Championship is not possible, since flyball is strictly a team sport. The Commission decided to describe the guidelines for a Flyball Open World Cup (FOWC), which should be organised every second year. In the meantime, these specifications were published on the FCI website and the Commission hopes to soon receive applications from NCOs,



applying to organise the very first FOWC in 2018. Applications should arrive in writing before the next meeting of the Commission, in the summer of 2017.

# FCI EARTH DOG COMMISSION – ACTIVITY REPORT


#### Meetings

#### Proposal 2: Standing Order of the FCI Article 10 – Events

The International all-breed shows and international trials where FCI awards (CACIB, CACIT, CACIAG, CACIL, CACIOB) are granted come under the aegis of the FCI. All documents and catalogues related to the above events must carry the FCI logo. The FCI logo must be visible at all these events.

<u>At World Dog Shows and Section Shows the FCI logo and</u> the FCI Flag must be visible at all these events, including at the main entrance and in the main ring.

As result of the change, the following text should also be added in the **APPLICATION FORM**.

#### WORLD DOG SHOW (WDS) and SECTION DOG SHOWS (SDS).

PRESENCE OF FCI LOGO AND FLAGS (in a central and "strategic" place, **including at the main entrance and in the main ring). Approval.** The matter will be referred to the 2017 General Assembly (amendments to the Standing Orders are for the GA). Once again I would like to thank Dinky B. Santos and the members of the Philippines Canine Club, Inc. for hosting our meeting and the great hospitality, Dr Orlino Hosaka for the perfect organisation and Mr Joselito Rosales for taking over the important work as the secretary for the meeting. Not to forget Mr Larry Yuen's sport lesson after lunch, which made us fit for the next discussions.



Even though the weather was not what at least the European delegates had expected, we spent a wonderful and memorable time in Cebu.

In this report I am very happy to mention that the World Dog Show in Moscow and the Section Shows in Brussels (Europe) and Jakarta (Asia) where organised with great empathies and attracted many exhibitors and visitors.



 This type of work. Each breed has its own style of work as a result of an ancient selection in different environments and with different herds.

In Collecting Style (CS), Border Collie and Kelpie, the number of FCI trials held is lower than in TS, but slowly increasing each year. A lot of Border Collies have double registrations, both FCI and ISDS. Their handlers are getting more interested in FCI CS. FCI trials CS are organised in Italy, Czech Republic, Poland, Sweden and Germany.

The FCI Commission for Herding dogs had its annual meeting in Bergamo (Italy), in June. Members of the following countries were present: Austria, Czech Republic, Finland, France, Italy, The Netherlands, Russia, San Marino Republic, Sweden, Switzerland.

Concerning the herding situation in the various countries, in general, the number of trials in Traditional Style (TS) is increasing and the level of performance gets higher each year. The implementation of the FCI Rules is however not equal in all of the countries. Some countries just start organising trials, like in The Netherlands. In other, there has been a tradition for a long time, like in France, Italy, Finland and in Czech Republic, with a lot of competing dogs. Every year we have the 27







In both styles there is an urgent need of judges. In some countries sufficient judges are acknowledged, but communication is not always easy and, in many countries, the rules to become a judge are complicated and the process takes too much time. In other countries, it is easier. On the Herding page of the FCI website we introduce a judges list following the communications of different country members to the commission's secretary.

In 2015 the commission decided to set up a new set of rules for herding. During the 2016 meeting, important work was done on the revision. The conditions for organisation, sheep management, animal welfare etc. are the same for all styles and levels. So, in the new set of rules, these conditions will be presented in:

#### INTERNATIONAL RULES FOR SHEEPDOG TRIALS General Conditions

Rules for NHAT (Natural Herding Aptitude Test) Rules for Tests and Trials Traditional Style Rules for HWT TS (Herding Working Test) Rules for International Herding Trials TS Rules for Tests and Trials Collecting Style Rules for HWT CS (Herding Working Test) Rules for international Herding Trials CS

The Working Group prepared a draft for the General Conditions. This proposal was talked over in the Commission and is almost finished. Also the Rules for the Herding Working Test, Traditional style were discussed. The Rules for IHT will be discussed by either e-mail or video-conference and prepared for the next meeting that will be held in Interlaken on 20-22 April, 2017. Rules and proposals for the organisation of a European

Championship will be discussed following the proposal of France and Italy to organise it together in Switzerland.

At the last meeting, Mario Masucci presented how his work and testing of the Protecting Dogs on the flock has developed over the years. In view of the great interest in this area in recent years the commission suggests that the FCI should appoint a special sub-committee about herding protecting dogs.

On the last day of the meeting, the delegates attended an official trial (traditional style). During the trial, the committee members had the opportunity to verify the level of the training of different dogs and breeds to make considerations on rules, application and judging.

The interest in herding dog activities, both collecting (Border Collies) and traditional (inter – breed) has increased in the last few years, and the Commission pointed out this recommendation to the FCI member countries, with the purpose to practice this activity under the FCI umbrella:

- if the country doesn't have a representative in the commission, nominate a delegate with interest and experience
- adopt the FCI Herding rules
- stimulate the organisation of tests and trials under FCI rules
- control of international trials following the FCI rules
- promote the formation of new herding judges with specific background

# FCI OBEDIENCE COMMISSION – ACTIVITY REPORT

The FCI Obedience Commission had its annual meeting on 14-15 May in Riga, Latvia. Representatives from thirteen countries participated. As we have had an extensive revision of our Obedience rules and regulations when combining classes 1-2-3 into one document and also composing some new exercises, there still seemed to be some work to make amendments and clarifications, many of which were discussed at our judges' meeting in 2015. At our annual meeting also the rules and regulations of international Obedience competitions with CACIOB were dealt with. The work consisting in changing some of the practices and discussing the guidelines of the World Winner competitions in Obedience is ongoing and will continue this year.

The World Winner competition 2016 in Obedience was arranged by the Russian Kynological Federation in Moscow, from the 30th of June until the 3rd of July. A very sincere thank you to all who participated in the work and provided us with such a nice and well-organised event. The competition site was the prestigious riding stadium of the Moscow Olympics 1980. This was an excellent place. The ground of the manege, a sandsawdust-fibre mixture, was very friendly for the dogs and they could really be at their very best.

Altogether, 80 competitors had enrolled from 15 countries. This is slightly less than usual and is probably due to the fact that the journey to Moscow was certainly long for those coming from the southern parts of Europe. Not all competitors or their dogs like to fly, and going by car did not seem to be so attractive as the journey was long. This then made it possible for reserves to enter the competition. The competition layout was a threeday event. The first two competition days were about getting the title of best team in the world, i.e. finding the World Winner team. The team competition is also a qualification competition for finding the 20 finalists competing for the title of individual World Winner on Sunday.

The judges were, as usual, from four different nations. The representative of Russia was Mrs Elena Limonova. It was the first time that Russia had a representative in the judging team. It was also the first time that Mrs Vladislava Akimova, from Latvia, judged at our WW competition. One could see that they were putting their heart into this and were extra keen to master the new rules when judging. The other two judges were



Mrs Jeannine Tschupp from Switzerland and Mr Ralf Björklund from Finland, both having earlier experience of judging WW Obedience competitions. Mrs Carina Savander-Ranne, from Finland was chief judge.

In the team competition the Finnish team once more won the golden medal and the World Winner title. The team's result was impressive with an average of almost 290 points and altogether 869.25 points. The Russian team has been doing good work in the last few years and they took second place and the Swedish team landed third. Both teams also having the average result of excellent, but some twenty points less than the winning team. In the competition for the individual World Winner title all three medallists came from Finland: gold medal Oili Huotari and bc Tending Occult, silver Hanna-Mari Ikonen and bc Borderness Just Tosi and bronze medal Carita Kuparinen and bc Saunajaakon Alfa Romeo.

The majority of the dogs were border collies with a few exceptions. There were some very nice performances by retrievers. Jesús Martín with his Labrador retriever Tyson did impressive work in the qualification competition on Saturday being second. Fourth in the individual was a golden retriever from Norway, Renate Lund with Vassruggens Ålga Mildir. A more rare breed in obedience today, a staffordshire bullterrier from Russia, Amurski Strazh Germiona handled by Maya Afanasova, showed some nice work and eagerness to do the exercises. It missed a place in the finals by 1.5 points and a few places. This staffordshire bullterrier received the price "the chief judge's favourite".

It was again nice to see so much friendship and good sportsmanship among all. The handling of the dogs was beautiful and both handlers and dogs seemed to enjoy themselves. Having watched obedience competitions for many years from both inside and outside the ring it has become clear that only happy dogs and happy handlers can succeed in this sport.

# FCI SHOW JUDGES COMMISSION - ACTIVITY REPORT

As usual, our annual meetings were held in the first week of February. Our host was the Philippine Kennel Club. We are grateful for their kind hospitality and for our memories of an educative, meaningful and agreeable weekend with a nice and unforgettable trip to a beautiful Paradise along the beach in Cebu.

Next to the meeting of the FCI Show Judges Commission, there were also meetings of the FCI Show Commission in the same weekend. We always end up in a joint meeting to discuss topics that involve both show judges and show organisers.

Our work and discussion often lead to several proposals for the FCI General Committee. More and more non-European countries enter the Show Judges Commission and that is a great achievement. That's why both commissions decided to once every few years have their meetings outside Europe. Only together we can make it work.

Nearly all proposals that had been sent to the FCI Board were accepted. This is the crown on hard work and good preparation by all of us. Thank you all for your cooperation! FCI General Committee's decisions to turn down proposals have to be motivated more properly. Sometimes these are very short. We take the opportunity to discuss the decisions with the FCI General Committee and/or Office when we feel too.

# Joint Meetings with our colleagues from the Show Commission

Like every year we also organised a joint meetings with the Show Commission. It is always the last meeting in our weekend during which we talk about topics that involve both commissions. But we also inform each other about the specific topics that can have an influence on the other commission.

In 2016, we talked about regulations for shows that affect judges and vice versa, the publishing of online catalogues, the ban of dogs and people at shows, the way to use online and digital systems in the ring, etc.

#### Mutual recognition of Judges by FCI and KC

A statement about the mutual recognition of judges by FCI and KC that the two Boards (FCI and KC) discussed in 2014 and approved in 2015 was withdrawn by the members of the KC. In 2016, the KC withdrew the agreement with the FCI because they were forced to by their members. We still wait for further development. Once again, judges are not treated equally in the world.

#### European Judges Directory

The FCI approved to coordinate this website from January 1st, 2014. More and more countries participate in this international list and more and more organisers use it to develop their judges lists for shows. In December 2014, an English version of the Administrator and User manuals was provided. This information was sent to the national canine organisations. The FCI General Committee decided this judges list to be

compulsory for all members from the 1st of July 2017. We are glad we finally can use "one" judges list for the FCI worldwide.

#### Breed-specific education

Our aim to have a uniform education for every individual breed, developed by the country of origin of the breed, for international use became reality. Unfortunately, most countries did not answer our request to develop some breed education PowerPoint presentations. A lot of countries started to develop these education PowerPoints, but never sent them. These PowerPoints are not only very helpful in educating judges all over the world, they also give the opportunity to develop uniform education for national breeds that can be spread and used by the whole world.

#### Guidelines and instructions how to write a dog's report

Throughout the last years, we often heard that judges have problems with writing good reports of dogs when judging. Basic guidelines and instructions about how to write reports and a list of words that can be used would be very helpful. It would also give judges better opportunities to find their way at shows where written reports are asked.

We prepared nothing more than guidelines about how to write a report and developed a list of the most common words used. It is up to the FCI countries to decide whether they use it in their education programme. The FCI Show Judges Commission submitted to the FCI General Committee to accept this document as guidelines and basic information about how to write a dog's report.

Germany, France and Uruguay finished the German, French and Spanish translations of the glossary. They will be integrated in our final guidelines.

Our members are free to use these guidelines in our countries to educate our judges! And some countries already did.

# The matter of "supposed incorrect nomination of judges" in some countries

Since quite a few years, the FCI has developed basic rules for education, examination and nomination of show judges and candidate judges. These basic rules must be followed and respected by all FCI members. We are highly surprised to hear very intense rumours that the nomination of group judges does not always follow the basic rules. We are now in discussion with the FCI how to control it and how to act when countries have not followed the rules for a long time. To us, the FCI General Committee should undertake more action and put pressure on their members who do not follow the rules. Judges worldwide should be treated equally, not only when judging, but also when becoming a judge. Therefore we keep on pushing FCI General Committee to act properly and actively.

#### Promotion of new judges

We also discussed in the joint meeting the way to promote young and/or new judges to judge at international level.

#### Assisting members and answering their questions

In 2016, we also regularly got questions from members regarding interpretation of rules, education programmes, nomination of judges and assistance on seminars and events. We are always willing to assist, together with our colleagues from the Show Commission Board. We also got several questions on the same matters, coming from the FCI Office, the FCI General Committee and our members and their countries.

In 2016, Mr John Wauben, the President of the FCI Judges Commission, was invited by the kennel club of Iran to educate their people for some breeds often seen in this country. Mr Wauben saw a lot of enthusiastic, willing and dog-loving people in a country that is still not that easy for dog-lovers. However the passion of the Board of the kennel club of Iran and its members will certainly lead Iran into a different way of looking at dogs.

In 2016, we were also involved in some FCI questions regarding judges, moving from non-FCI countries to FCI Countries. We are glad that FCI asks our advice about the nomination of these judges.

#### Further topics in 2016

Besides the above-mentioned topics we also spoke about:

Obligations for NON-FCI Judges officiating at shows. They should not only have the same rights, but also the same obligations when judging at FCI shows. We suggested an amendment to the Regulations.

Physical and mental health to judge in the ring. It was added to the Regulations that judges must be fit in order to judge the breeds assigned to them, paying respect to dogs and exhibitors. We suggested to change the Standing Orders regarding the information regarding judges published in the official judges list. Next to the already-mentioned details, the national canine organisation should also mention the year the judge was nominated for his/her first breed. It is necessary to check whether the nomination of All-Breed Judges was done properly.



In 2016, the Executive Committee of the FCI Show Judges Commission was:

The President, Vice-president and Secretary met once to prepare the agenda together. Several topics were discussed in the past year by email and at shows. You will largely find these mentioned on the agendas of the commission's meetings.

We thank Yves De Clercq and his colleagues from the FCl office in Thuin for the way in which our documents were at all times sent promptly and correctly translated for our members and our thanks also go to the FCl Board member Tamàs Jakkel who supported and defended our proposals.

#### Contact with our members

We tried to spread new information as soon as possible to our members. Members received several mails regarding our actions. We also inform our members about the FCI decisions regarding judges.

Again a year that passed very quickly. A year in which social pressures on our dogs and on ourselves as show judges intensified considerably in many countries. We must jointly make strong efforts for promoting fine, healthy, social and fit-for-function dogs. That will have to be a basic theme of our discussions and concerns in the coming years.

We prepared new Regulations for International Sighthound Races and Lure Coursing Events.

The annual meeting of the FCI Commission for Sighthounds Races took place in Velke Pole, Slovakia, on June 16th. We planned 84 races and 98 lure coursing.

The European Championship Coursing was held in Velke Pole, Slovakia on 17-19.6.2016. Over 890 participants were announced. We had 29 European Lure Coursing Champions from 14 different countries.



The European Championship Racing was held in Toulouse, France on 2-4.9.2016, over 250 participants were announced. We had 18 World Racing Champions from 8 different countries.

# FCI COMMISSION FOR SLEDGE DOGS – ACTIVITY REPORT

In 2016 the FCI Commission for Sledge Dogs continued its work and met in Vilnius, Lithuania, on 21 and 22 May. A perfectly well organised meeting thanks to the organisers, Mrs Laura Baryte and the Lithuanian Kennel Club.

The Commission welcomed three new countries participating now in its work, namely Latvia, Lithuania and Switzerland, increasing the number of participating countries to 16.

The meeting started with some explanations on the work already done by the commission, the guidelines approved in 2014 that were also approved by FCI General Committee. New participants took the opportunity to express some views and remarks on these guidelines.

Then the work of the commission focused mainly on the discussion, on a coherent basis, of two different but complementary issues, the drafting of a set of rules for the delivery of CACIT for sledge dogs possibly on snow races, and another one to establish the requirements in order to be able to get the title of International Working Champion.

As these rules would be FCI rules once adopted by the FCI General Committee, a long discussion took place about the possibility for FCI Member countries to be allowed to organise CACIT races on dryland races for countries that do not have snow. Many other issues were discussed like the minimum result on show to be eligible to the delivery of a CACIT as well as the minimum distances per class on CACIT races.

It is foreseen to be in the position to discuss and possibly finalise the drafts for these two sets of rules at the next meeting of the commission.

The next meeting of the commission is planned to be held on 27th and 28th May 2017 in Budapest.

# FCI COMMISSION FOR SPANIELS – ACTIVITY REPORT

The meeting of the FCI Commission for Spaniels took place on November 28th in Blingel (France), in the frame of the 9th European Cup for Spaniels which was held in Blingel on November 28th and 29th.

As was already the case in 2015, The Netherlands were unable to organise the European Cup in 2016. In an effort to address the shortcoming, France – who deserves our heartfelt thanks – stepped forward to take over the organisation of the 2016 edition.

The Commission's meeting was successful and was attended by new countries: Belgium, France, The Netherlands and Italy were joined by Sweden and Finland.

We discussed the regulations in effect in various countries, which need to be aligned with the Standing Orders of the FCI so as to allow further CACIT trials to be organised.

As far as the "A" set of rules is concerned, the approved countries are: Belgium - France - Ireland and Italy; that of The Netherlands, which the Commission has endorsed, is in the process of being approved.

During the meeting, we discussed the possible amendments to the "A" set of rules and to that of the FCI European Cup. The arguments will be reconsidered during the next meeting of the Commission, which will take place in Pisa on May 20th 2017. There, we expect the countries that apply the "B" Regulations of the FCI to be present, so they can let us know in what way they wish the Regulations to be amended, considering the significant volume of derogation requests.

The following countries took part in the European Cup for Spaniels: France, Belgium, The Netherlands, Italy, Spain.

2. - OPINION



# Letter of Understanding between FOI and AKC

WHEREAS the Fédération Cynologique Internationale (FCI) and The American Kennel Club (AKC) share the common goals of promoting and protecting purebred dogs; and

WHEREAS the parties hereto have in the past cooperated to a certain extent in carrying out this object and have been acting pursuant to certain informal agreements made from time to time for that purpose; and

WHEREAS it is agreed that the relations between AKC and FCI and its member registries should be explicitely written with a view towards future cooperation;

NOW, this letter of understanding encompasses the mutually agreed to basis for the relationship between the parties as follows:

- AKC will recognize the pedigree for any FCI registry that meets AKC requirements and that wishes to have such recognition.
- AKC will not automatically give exclusive recognition to the FCI registry in any country in which there are multiple registries and FCI will not automatically give exclusive recognition to AKCs registry in the United States.
- 3. AKC will not register any dog born in an FCI member country until that dog has been registered in the Stud Book of the FCI registry or the AKC-recognised registry in that country. No dog born in the USA, belonging to breeds recognised by the AKC, will be registered by an FCI member registry unless the dog has been registered in the FCI-recognised registry in the United States. It is up to the FCI to decide about the registration of dogs born in the USA belonging to breeds not recognised by the AKC.
- 4. Each of the parties agree that when any information comes to its knowledge which might reasonably affect or be useful to the other party (AKC judges suspension, amended standards, etc.), it will immediately communicate such information to the other party.
- FCI and AKC will deal with the judging approval reciprocity in a separate document (see attachment).

- 6. AKC will not sponsor any event in the country of an FQ member without the express permission of FQ and the FQ member. FQ will not sponsor any event within the territory of the United States without the express permission of AKC. Puerto Rco is exempted from this provision as both AKC and FQ have been previously sponsoring activities on that island.
- 7. While not an FQ member, FQ has graciously agreed to permit AKC to participate in its World or Section Agility, Utility, Obedience, etc. Championship Championship Event provided that this participation does not prevent representative teams of FQ member organisations from taking part. If the AKC teams win the competition, they are not eligible for the title of FQ Winner at these events.
- 8. AKC registered dogs are eligible for the title of FCI International Champion under specific conditions to be agreed upon by the AKC and FCI.
- 9. Except with the agreement of the AKC, the FCI will not register kennel names for breeders living in USA (with exception of Puerto Rico) and, except with the agreement of the FCI, the AKC will not register kennel names for breeders living in countries where the FCI has a member, which the AKC has accepted.
- 10. FO agrees to send to the AKC headquarters all revised breed standards and AKC agrees to send to the FO headquarters copies of its Complete Dog Book, which includes all AKC standards, each time that such publication is revised.
- The terms of this letter of understanding is agreed to by the parties listed below. This agreement may be terminated by either party upon reasonable notification to the other party.

# Breed Judging

At FCI CACIB international shows, the AKC judges are eligible to judge and award the CACIB provided that the two following conditions are fulfilled:

- the breeds they are scheduled to judge are recognised by the AKC (this does not include FSS and Miscellaneous classes).
- the judges in question are allowed to judge, under AKC regulations, the breeds in question at AKC events and award them championship points. An AKC judge, residing in the United States, may not be approved as an FQ judge (breed, group, all breed) eligible to award CAQB.

At AKC events, the FCI judges are eligible to judge and award championship points provided that the following conditions are fulfilled:

- the breeds they are scheduled to judge are recognised by the FCI and by the national kennel dub, in their country of residence, which has jurisdiction over the judges in question
- 2. the judges are members of their national kennel club, in their country of residence, which is an FC member or contract partner
- the judges in question are allowed to judge, under FCI regulations, the breeds in question at FCI International CACIB shows and award them the CACIB

# Group and BIS Judging

It is up to both, the AKC and the FCI members, to choose to invite or not a judge to judge a particular group (according to FCI or AKC breed nomenclature) at an AKC event or at an international FCI CACIB show taking into consideration the experience of the judge, his judging credentials and the breeds and their numbers in the groups to judge.

# Letter of Understanding between the Fédération Cynologique Internationale and the Kennel Club

WHEREAS the Fédération Cynologique Internationale (FCI) and the Kennel Club (KC) share the common goals of promoting and protecting, in the case of the FCI, pedigree dogs and in the case of the Kennel Club, all dogs; and

WHEREAS the parties hereto have in the past cooperated to a certain extent in carrying out this object and have been acting pursuant to certain informal agreements made from time to time for that purpose; and

WHEREAS it is agreed that the relations between KC and FCI and its member registries should be explicitly written with a view towards future cooperation;

NOW, this letter of understanding encompasses the mutually agreed basis for the relationship between the parties as follows:

- The KC, where it recognises the breed in question, will recognise the pedigree
  of any FCI registry that meets KC requirements and that wishes to have such
  recognition.
- 2. In so far as it is lawful, the KC will give exclusive recognition to the FCI registry in any country in which there are multiple registries provided that these registries meet KC requirements and the FCI will give exclusive recognition to the KC's registry in the United Kingdom. For the time being this will not include Malta and China.
- 3. The KC will not register any dog, or issue a pedigree to any dog, born in an FCI member country whose registry the KC recognises, until that dog has been registered in the FCI registry in that country. No dog born in the UK will be registered, or have a pedigree issued, by an FCI member registry unless the dog has been registered by the KC in the United Kingdom.
- 4. Each of the parties agree that when any information comes to its knowledge which might reasonably affect or be useful to the other party (KC or FCI judges suspension, amended standards, etc.), it will immediately communicate such information to the other party.
- 5. The FCI and the KC will endeavour to agree on the conditions to make their respective judges eligible to officiate at events sanctioned by them (FCI and KC).
- 6. The KC will not sponsor or support any event for dogs in the country of a current FCI member without the express permission of the FCI member. The FCI will not sponsor or support any event for dogs within the territory of the United Kingdom without the express permission of the KC. For the time being this will not include Malta and China.

- 7. While the KC is not an FCI member, the FCI has graciously agreed to permit the KC to participate in its World or Section Agility, Utility, Obedience, etc. Championship Event provided that this participation does not prevent representative teams of FCI member organisations from taking part. The KC teams may win the competition but are not eligible for the title of FCI Winner at these events.
- The FCI agrees to send to the KC headquarters all revised breed standards and the KC agrees to send to the FCI headquarters copies of all revised breed standards. The FCI and KC will discuss health issues connected with breed standards on a regular basis.
- FCI members are allowed to refer to the title of UK Champion by using the abbreviation "UK Ch + name of the dog".
- 10. Except with the agreement of the KC, the FCI will not register kennel names of breeders living in the UK and, except with the agreement of the FCI, the KC will not register kennel names of breeders living in countries where the FCI has a member, which the KC has accepted.
- 11. The terms of this letter of understanding are agreed to by the parties listed below. This agreement may be terminated by either party upon reasonable notification to the other party.

# Memorandum of Understanding between FCI and CKC

WHEREAS the Fédération Cynologique Internationale (FCI) and The Canadian Kennel Club (CKC) share the common goals of promoting and protecting purebred dogs;

WHEREAS the CKC and the FCI have, in the past, cooperated to a certain extent in carrying out these goals and have been acting pursuant to certain informal agreements made from time to time for that purpose;

WHEREAS it is recognized that both the FCI and the CKC are required to operate within the limits of the legislation governing their activities, including their respective constitution and by-laws;

NOW this letter of understanding expresses a mutually agreed to basis for the relationship between the CKC and the FCI as follows:

- The CKC acknowledges the role of the FCI and its governing institutions as set out in the FCI Statutes as the primary world federation of dog registries.
- 2. The FCI acknowledges the CKC as the primary kennel club in Canada.
- The CKC and the FCI agree that when any information comes to the knowledge of one party, which might reasonably affect or be useful to the other party (judges suspension, amended standards etc.), it will immediately communicate, in writing, such information to the other party.
- The parties will meet at the request of either of them, within a reasonable timeframe and on basis of a consistent mutually agreed agenda which will include matters of common interest.

- 5. The FCI agrees to send to the CKC head office a copy of all breed standards with revisions as they occur and CKC agrees to send to the FCI headquarters all CKC breed standards with revision as they occur. The FCI and CKC will also share information concerning the decisions of their respective governing bodies such as the exchange of official publications.
- 6. The CKC will periodically provide the FCI with a list of the registries from the FCI member countries with which the CKC has reached an agreement providing for the mutual recognition of studbooks and pedigrees. The CKC will get in touch with all the FCI members and contract partners and inform them about the procedure to follow to gain CKC recognition. The FCI will notify the CKC of the accession of any country to FCI membership.
- The details of a mutual recognition of FCI and CKC judges are written on a document which is part of this contract.
- The FCI will not sponsor or sanction any event within Canada without the express permission of the CKC.
- The CKC will not sponsor or sanction any event in an FCI member country without the express permission of the FCI and the agreement of the member country.
- 10. While not an FCI member, FCI graciously agrees to permit CKC to participate in its World or Section Agility, Utility, and Obedience Championship Events and any forthcoming canine performance event that may be mutually recognized by both organizations.
- 11. As long as no agreement is reached with regard to the working breeds (according to the FCI nomenclature) between the FCI and CKC, these breeds (CKC-registered dogs) are not eligible for the title of "International Beauty Champion". The non-working breeds (CKC-registered dogs) are eligible for this title provided that they comply with the FCI International Championship Regulations, i.e. 4 CACIB in 3 countries under 3 different FCI judges.
- 12. The CKC registered dogs are eligible for the other FCI international titles provided that they meet with the FCI requirements.
- 13. The FCI international directory of kennel names (affixes) is not open to CKC breeders and the FCI cannot guarantee that a CKC kennel name (affix) will not be similar to an FCI registered kennel name (affix) and conversely.

- 14. Both parties agree that the present Letter of Understanding shall not be interpreted or applied so as to require either party to act in a manner not authorized by or contrary to applicable legislation, including each party's constitution, rules or by-laws.
- 15. The terms of this Letter of Understanding are agreed to by both parties. This agreement may be terminated by either party upon giving the other party 60 days notice in writing.

# CKC Judges eligibility to officiate at FCI International Events

From April 1st, 2009, the following dispositions will apply:

- a) CKC judges are allowed to judge in the FCI member countries all-breed, group and specialty national shows, the breeds they are approved to judge in Canada.
- b) CKC judges who have already judged international FCI CACIB shows before December 31<sup>st</sup>, 2007, are allowed to award CACIB at international FCI CACIB shows, FCI World and Sections shows, to the breeds they are approved to judge in Canada.
- c) Once a CKC judge has judged four (4) national shows in four (4) different FCI member countries by the FCI breed standards, he/she is allowed to award CACIB to the breeds he/she is approved to judge in Canada.

It will be the responsibility of the FCI Office and of the judges concerned to keep track of assignments undertaken in an FCI member country. Taking into account the legal restrictions on the exercise of extra-territorial jurisdiction by the CKC, it will be the responsibility of the CKC to communicate them to their judges and the practical implementation and enforcement of the agreed above principles will be under the responsibility of the FCI Office, of the FCI members and the judges concerned.
