Welcome to the FCI judges Directory. We herewith invite you to read these few lines carefully.

All judges listed in the FCI judges Directory are <u>under the exclusive responsibility of</u> the National Canine Organization (NCO) of the **Country** where he(she) has his(her) legal residence (referred to as **NCO in charge of the judge).** A list of NCO members and contract partners of the FCI are available under <u>Members</u>.

The members and contract partners are divided into FCI Sections (referred to as **Section**): <u>The Americas</u> & <u>Caribbean</u> - <u>Europe</u> - <u>Asia, Africa & Oceania</u>

Only a very limited number of show judges are under the responsibility of the FCI (referred to as **FCI** in the list of **Countries**)

An identification number (consisting of the two-letter ISO code of the country (NCO) in charge of the judge followed by a sequence number) (referred to as **Number**) is assigned to each judge in this Directory.

Example: BR14 = identification number for a Brazilian judge <u>under the responsibility of the Confederação Brasileira de Cinofilia (BRAZIL)</u>.

For judges under the responsibility of the FCI, the two-letter ISO code of the country has been replaced by the initials FCI (Fédération Cynologique Internationale).

Example: FCI4 = identification number for a judge under the responsibility of the FCI.

In accordance with the new European legislation regarding DATA PROTECTION (GDPR) in force since May 25 2018, only the **Last name** and the **initial of the First name** of the FCI judges listed are mentioned in this Directory and no single contact data is available. A limited number of data like

- 1) the FCI or other languages spoken by the judge,
- 2) detailed information regarding authorizations specific to the discipline <u>Shows</u> (FCI breed and group judges, BIS judges, FCI all-breed national and international judges and judges of a breed not officially recognized by the FCI),
- 3) the period and level (national or international) of a current suspension or exclusion of a judge

can be viewed in the sheet of the judge.

However, additional information (contact data, detailed curriculum vitae, etc.) can be obtained <u>from the judge</u> and/or <u>the NCO in charge of the judge</u>, but only through the contact form available in the result list of judges.

For each judge listed in this Directory, the FCI discipline (referred to as **Discipline**) for which the judge has been authorized appears in the result list of judges.

Example: Discipline = Shows for judges that are allowed to officiate at FCI international CACIB shows.

Finally, any judge listed in this Directory has a status (referred to as **Status**): active, suspended or excluded. The details about a suspension or exclusion of a judge can be viewed in the judge sheet.

About show judges:

- 1) An advanced search tool (search for FCI breed and group judges, BIS judges, FCI all-breed national and international judges and judges of a breed not officially recognized by the FCI) is available, only if the discipline Shows has been previously selected.
- 2) For show judges whose Last name is followed by a 1 a written authorization issued by the national canine organization in charge of the judge is required to judge at a FCI international CACIB show.
