LISTS OF **HERDING/LIVESTOCK GUARDIAN** DOG BREEDS THAT CAN TAKE PART IN FCI EVENTS AND RECEIVE FCI TITLES AND AWARDS

INTRODUCTION

- 1.1. FCI Herding Dogs Commission's (FCI HDC) priority is to maintain the working ability of dog breeds to serve livestock. In addition to health, anatomy and appearance, which is the main objective of current dog breeding, it is equally important to preserve and develop the original inner qualities and instincts.
- 1.2. The challenges of keeping livestock have led to the breeding of dogs that are excellent at herding or/and guarding. Historical, economic and farming changes have also affected dog breeding and the selection of these breeds has led to a loss of working ability. Despite the fact that these dogs are essentially born to work, the breed standard no longer requires a working test as a condition for breeding.
- 1.3. Some breeds are subject to a working trial (indicated in the breed standard) as instructed by the National Canine Organisation (NCO) of their country of origin (see [TABLE 1](#) BELOW).
- 1.4. Some NCOs however have obtained the FCI permission to include their own native breeds, not subject to a working trial, in the FCI list of breeds exceptionally allowed to be entered in working class (see [TABLE 2](#) BELOW).
- 1.5. The FCI HDC introduced test and trial rules for Herding and Livestock Guardian dogs. These rules are applied to preserve the characteristics related to the ability to handle livestock and maintain these aptitudes through the work of many dog generations. The events organised on the basis of these rules are open to more breeds than those referred to at 1.3.
- 1.6. Although the various tests and trials are open to a wide range of breeds, the FCI titles and awards that can be gained are not available for all these breeds.
- 1.7. This document informs about the breeds concerned. The lists in the next tables can be adapted, if necessary, by the FCI HDC.

TABLE 1: Herding dog breeds subject to a working trial according to the FCI breeds nomenclature,

- eligible to enter the working class at international FCI-CACIB shows based on results obtained in **HERDING dog work** (passed FCI-HWT, Traditional or Collecting style)
- eligible for the **C.I.B.** title (**2 CACIB** & a passed FCI-HWT, Traditional or Collecting style)
- eligible for FCI title (**C.I.TR.**) and award (**C.A.C.I.TR.**) based on results obtained in **FCI-IHT-3 (Herding work)**

These breeds are eligible for the

- **C.I.B.** (4 CACIB or 2 CACIB + a passed FCI-HWT TS or FCI-GWT for breeds with optional working trial, only in case option “working” is chosen by the NCO)
- FCI title (**C.I.TR.**) and award (**C.A.C.I.TR.**) based on results obtained in **FCI-IHT-3 (Herding work)**
